Nama

1. Perintah ini bolehlah dinamakan **Perintah Suruhanjaya Integriti Agensi Penguatkuasaan (Pindaan Jadual) 2021**.

Pindaan Jadual

2. Jadual kepada Akta Suruhanjaya Integriti Agensi Penguatkuasaan 2009 dipinda—
 - (a) dengan memotong butiran “Ikatan Relawan Rakyat Malaysia (RELA)”;
 - (b) dengan memotong butiran “Jabatan Penerbangan Awam”;
 - (c) dengan memasukkan selepas butiran “Jabatan Perlindungan Hidupan Liar dan Taman Negara” butiran “Jabatan Sukarelawan Malaysia (RELA)”;
 - (d) dengan menggantikan butiran “Kementerian Pelancongan Malaysia (Unit Penguatkuasaan Bahagian Pelesenan) dengan butiran “Kementerian Pelancongan, Seni dan Budaya (Bahagian Pelesenan Pelancongan)”;
 - (e) dengan menggantikan butiran “Kementerian Perdagangan Dalam Negeri, Koperasi dan Kepenggunaan (Bahagian Penguatkuasaan)” dengan butiran “Kementerian Perdagangan Dalam Negeri dan Hal Ehwal Pengguna (Bahagian Penguatkuasaan)”;

(f) dengan menggantikan butiran “Lembaga Pelesenan Kenderaan Perdagangan” dengan butiran yang berikut:

“Lembaga Pelesenan Kenderaan Perdagangan (Sabah)
Lembaga Pelesenan Kenderaan Perdagangan (Sarawak)”; dan

(g) dengan memasukkan selepas butiran “Pendaftar Perniagaan”
butiran “Pihak Berkuasa Penerbangan Awam Malaysia”.

ENFORCEMENT AGENCY INTEGRITY COMMISSION ACT 2009

ENFORCEMENT AGENCY INTEGRITY COMMISSION
(AMENDMENT OF SCHEDULE) ORDER 2021

IN exercise of the powers conferred by section 55 of the Enforcement Agency Integrity Commission Act 2009 [Act 700], the Prime Minister makes the following order:

Citation

1. This order may be cited as the **Enforcement Agency Integrity Commission (Amendment of Schedule) Order 2021**.

Amendment of Schedule

2. The Schedule to the Enforcement Agency Integrity Commission Act 2009 is amended—

- (a) by deleting the item “Ikatan Relawan Rakyat Malaysia (RELA)”;
- (b) by deleting the item “Civil Aviation Department”;
- (c) by inserting after the item “Department of Wildlife and National Parks” item “Volunteers Department of Malaysia (RELA)”;
- (d) by substituting for the item “Ministry of Tourism Malaysia (Enforcement Unit of Licensing Division)” the item “Ministry of Tourism, Arts and Culture (Tourism Licensing Division)”;
- (e) by substituting for the item “Ministry of Domestic Trade, Co-operatives and Consumerism (Enforcement Division)” the item “Ministry of Domestic Trades and Consumer Affairs (Enforcement Division)”;

(f) by substituting for the item “Commercial Vehicles Licensing Board” the following items:

“Commercial Vehicles Licensing Board (Sabah)
Commercial Vehicles Licensing Board (Sarawak)”; and

(g) by inserting after the item “Registrar of Businesses” item “Civil Aviation Authority of Malaysia”;
