PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 6) 2021

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sembilan, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 6) 2021**.

(2) Perintah ini mula berkuat kuasa pada 25 Jun 2021 .

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama—

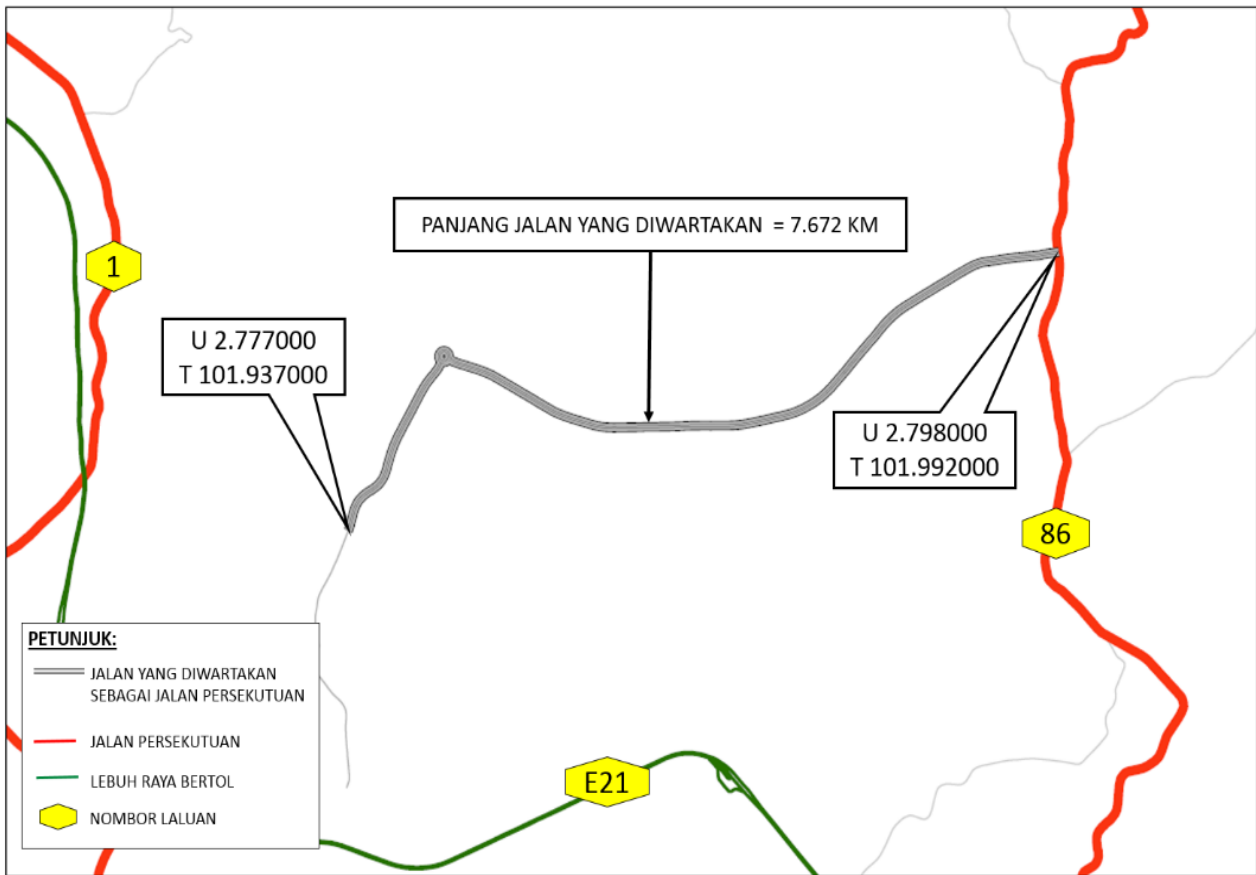
(a) di bawah kepala "**Negeri Sembilan Darul Khusus**" dengan memasukkan selepas butiran 26 butiran yang berikut:

"27. *(Laluan 366): Jalan Temiang–Pantai*

Bermula dari persimpangan Laluan 86, Jalan Seremban–Kuala Klawang–Simpang Pertang di koordinat U 2.798000, T 101.992000 dan berakhir di koordinat U 2.777000, T 101.937000 di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA 14: JALAN TEMIANG-PANTAI (jarak sepanjang 7.672 km)."; dan

(b) dengan memasukkan selepas PETA 13: JALAN-JALAN PERSEKUTUAN NEGERI SEMBILAN peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 6) ORDER 2021

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Negeri Sembilan, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 6) Order 2021**.

(2) This Order comes into operation on 25 June 2021.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule—

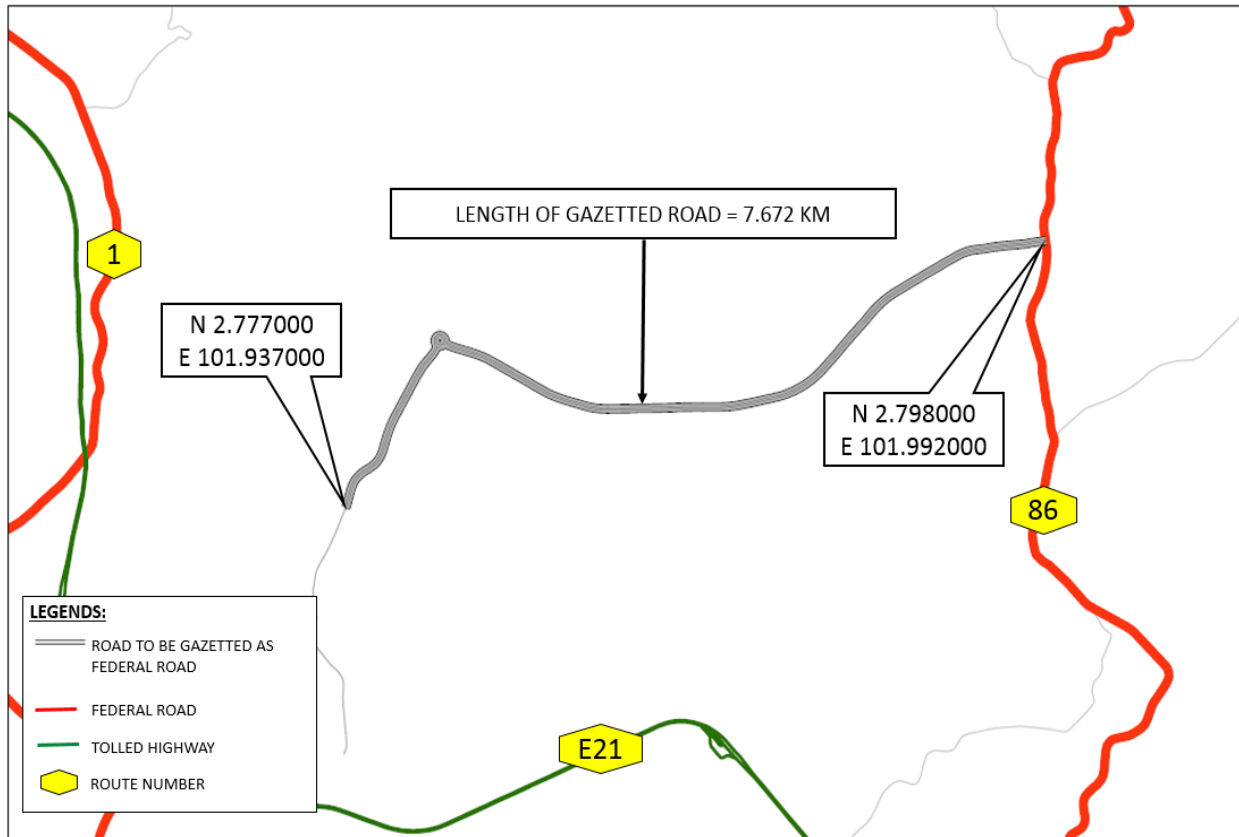
(a) under the heading of “**Negeri Sembilan Darul Khusus**” by inserting after item 26 the following item:

“27. (*Route 366*): *Temiang-Pantai Road*

Starting from the junction of Route 86, Seremban–Kuala Klawang–Simpang Pertang Road at coordinates N 2.798000, E 101.992000 and ending at coordinates N 2.777000, E 101.937000 within the boundaries of right of way as shown on MAP 14: TEMIANG–PANTAI ROAD (a distance of 7.672 km).”; and

(b) by inserting after MAP 13: FEDERAL ROADS OF NEGERI SEMBILAN the following map:

“MAP 14: TEMIANG-PANTAI ROAD”
