Nama

EMPLOYMENT INSURANCE SYSTEM ACT 2017

EMPLOYMENT INSURANCE SYSTEM (SUPPLY) REGULATIONS 2021

IN exercise of the powers conferred by subsection 48(1) of the Employment Insurance System Act 2017 [Act 800], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employment Insurance System (Supply) Regulations 2021**.

Issue for expenditure for the year 2021

2. The issue of a sum not exceeding two hundred and forty-five million five hundred and ninety-five thousand ringgit (RM245,595,000) from the Employment Insurance Fund for the expenditure on administration of the Employment Insurance System for the year 2021 is hereby authorized for the purposes specified in the Schedule.
