PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA (PERBEKALAN) 2021

Nama

1. Peraturan-Peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) 2021**.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (SUPPLY) REGULATIONS 2021

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employees' Social Security (Supply) Regulations 2021**.

Issue for expenditure for the year 2021

2. The issue of a sum not exceeding one billion one hundred and five million five hundred and fifty-two thousand ringgit (RM1,105,552,000) from the Social Security Fund for the expenditure on administration of the Scheme of Social Security for the year 2021 is hereby authorized for the purposes specified in the Schedule.
