PERATURAN-PERATURAN PENCEGAHAN DAN PENGAWALAN PENYAKIT BERJANGKIT
(LANGKAH-LANGKAH DI DALAM KAWASAN TEMPATAN JANGKITAN)

PADA menjalankan kuasa yang diberikan oleh subseksyen 11(2) Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan) (No. 4) (Pindaan) (No. 16) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 6 Mei 2021.

Penggantian peraturan 2

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan) (No. 4) 2021 [*P.U. (A) 96/2021*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan peraturan 2 dengan peraturan yang berikut:

“Pemakaian

2. Peraturan-Peraturan ini hendaklah terpakai bagi kawasan tempatan jangkitan, atau bahagian, daerah, mukim atau tempat, dalam kawasan tempatan jangkitan, dan bagi tempoh, yang ditetapkan dan diumumkan oleh Kerajaan dari semasa ke semasa dan disiarkan dalam laman sesawang Majlis Keselamatan Negara.”.

Pemotongan Jadual Pertama

3. Peraturan-Peraturan ibu dipinda dengan memotong Jadual Pertama.

PREVENTION AND CONTROL OF INFECTIOUS DISEASES
(MEASURES WITHIN INFECTED LOCAL AREAS) (MOVEMENT CONTROL)
(NO. 4) (AMENDMENT) (NO. 16) REGULATIONS 2021

IN exercise of the powers conferred by subsection 11(2) of the Prevention and Control of Infectious Diseases Act 1988 [*Act 342*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) (No. 4) (Amendment) (No. 16) Regulations 2021**.

(2) These Regulations come into operation on 6 May 2021.

Substitution of regulation 2

2. The Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) (No. 4) Regulations 2021 [*P.U. (A) 96/2021*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for regulation 2 the following regulation:

“Application

2. These Regulations shall apply to the infected local area, or division, district, mukim or place, in the infected local area, and for the period, as determined and announced by the Government from time to time and published in the website of the National Security Council.”.

Deletion of First Schedule

3. The principal Regulations are amended by deleting the First Schedule.
