PERINTAH KAWALAN BEKALAN (BARANG-BARANG KAWALAN) (PINDAAN) 2021

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Barang-Barang Kawalan) (Pindaan) 2021**.

**Pindaan Jadual**

2. Perintah Kawalan Bekalan (Barang-barang Kawalan) 1973 [*P.U. (A) 32/1973*] dipinda dalam Jadual dengan memotong—

(a) perkataan “Ubat serangga.”; dan

(b) perkataan “Cuka getah atau apa-apa cuka-cuka lain yang digunakan untuk membeku getah.”.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (AMENDMENT) ORDER 2021

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Control of Supplies (Controlled Articles) (Amendment) Order 2021**.

**Amendment of Schedule**

2. The Control of Supplies (Controlled Articles) Order 1973 [*P.U. (A) 32/1973*] is amended in the Schedule by deleting—

(a) the word “Insecticides.”; and

(b) the words “Formic acid or any other acid used for coagulating latex.”.
