ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (DEMERIT POINTS) (AMENDMENT) RULES 2021

IN exercise of the powers conferred by subsections 35(2) and 35A(2) of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

**Citation and commencement**

1. (1) These rules may be cited as the **Road Transport (Demerit Points) (Amendment) Rules 2021**.

(2) These Rules come into operation on 26 April 2021.

**Amendment of Schedule**

2. The Schedule to the Road Transport (Demerit Points) Rules 2017 [P.U. (A) 110/2017] is amended by deleting paragraphs 3, 4 and 5.
