Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Pelatih di Montfort Youth Training Centre, Kota Kinabalu, Sabah) 2021**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 November 2020.

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam butiran 1(a)(i) Jadual Kedua kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Caj) 2016 [*P.U. (A) 86/2016*] diketepikan berkenaan dengan seseorang pelatih warganegara yang memohon bagi pengiktirafan kemahiran yang membawa kepada penganugerahan Sijil Kemahiran Malaysia melalui Montfort Youth Training Centre, Kota Kinabalu, Sabah.

(2) Penepian fi di bawah subperaturan (1) adalah terpakai bagi permohonan pengiktirafan kemahiran yang dibuat dalam tempoh tiga tahun mulai 1 November 2020 hingga 31 Oktober 2023.

NATIONAL SKILLS DEVELOPMENT (WAIVER OF FEE TO TRAINEE AT MONTFORT
YOUTH TRAINING CENTRE, KOTA KINABALU, SABAH) REGULATIONS 2021

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Skills Development (Waiver of Fee to Trainee at Montfort Youth Training Centre, Kota Kinabalu, Sabah) Regulations 2021**.

(2) These Regulations are deemed to have come into operation on 1 November 2020.

Waiver of fee

2. (1) Subject to subregulation (2), the fee prescribed in item 1(a)(i) of the Second Schedule to the National Skills Development (Fees and Charges) Regulations 2016 [P.U. (A) 86/2016] is waived in respect of a citizen trainee who applies for recognition of skills leading to the award of the Malaysian Skills Certificate through Montfort Youth Training Centre, Kota Kinabalu, Sabah.

(2) The waiver of fee under subregulation (1) is applicable to application for recognition of skills made within the period of three years from 1 November 2020 to 31 October 2023.
