PERATURAN-PERATURAN PENCEGAHAN DAN PENGAWALAN PENYAKIT BERJANGKIT  
(PENGKOMPANAN KESALAHAN-KESALAHAN) (PINDAAN) (NO. 5) 2021

PADA menjalankan kuasa yang diberikan oleh seksyen 31 Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompanaan Kesalahan-Kesalahan) (Pindaan) (No. 5) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 11 Mac 2021.

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompanaan Kesalahan-Kesalahan) 1993 [*P.U. (A) 327/1993*] dipinda dalam peraturan 2 dengan menggantikan perkataan “pegawai awam yang diberikuasa olehnya secara bertulis” dengan perkataan “pegawai diberi kuasa yang diberi kuasa oleh Ketua Pengarah secara bertulis”.

PREVENTION AND CONTROL OF INFECTIOUS DISEASES  
(COMPOUNDING OF OFFENCES) (AMENDMENT) (NO. 5) REGULATIONS 2021

IN exercise of the powers conferred by section 31 of the Prevention and Control of Infectious Diseases Act 1988 [Act 342], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Compounding of Offences) (Amendment) (No. 5) Regulations 2021**.

(2) These Regulations come into operation on 11 March 2021.

**Amendment of regulation 2**

2. The Prevention and Control of Infectious Diseases (Compounding of Offences) Regulations 1993 [*P.U. (A) 327/1993*] are amended in regulation 2 by substituting for the words “public officer authorised in writing by him” the words “authorized officer authorized by the Director General in writing”.
