**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan Bersyarat) (No. 4) (Pindaan) (No. 2) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 11 Mac 2021.

CONTROL) (NO. 4) (AMENDMENT) (NO. 2) REGULATIONS 2021

IN exercise of the powers conferred by subsection 11(2) of the Prevention and Control of Infectious Diseases Act 1988 [*Act 342*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Conditional Movement Control) (No. 4) (Amendment) (No. 2) Regulations 2021**.

(2) These Regulations come into operation on 11 March 2021.

**Amendment of regulation 19**

2. The Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Conditional Movement Control) (No. 4) Regulations 2021 [*P.U. (A) 97/2021*] are amended in subregulation 19(1) by substituting for the words “one thousand ringgit” the words “fifty thousand ringgit”.
