REGULATIONS 2021

IN exercise of the powers conferred by subsection 11(2) of the Prevention and Control of Infectious Diseases Act 1988 [*Act 342*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Conditional Movement Control) (No. 3) (Amendment) (No. 2) Regulations 2021**.

(2) These Regulations come into operation on 3 March 2021.

Substitution of First Schedule

2. The Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Conditional Movement Control) (No. 3) Regulations 2021 [*P.U. (A) 65/2021*] are amended by substituting for the First Schedule the following schedule:
