PERATURAN-PERATURAN PENCEGAHAN DAN PENGAWALAN PENYAKIT BERJANGKIT
(PENGKOMPANAN KESALAHAN-KESALAHAN) (PINDAAN) (NO. 3) 2021

PADA menjalankan kuasa yang diberikan oleh seksyen 31 Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompanaan Kesalahan-Kesalahan) (Pindaan) (No. 3) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 19 Februari 2021.

Pindaan Jadual Pertama

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompanaan Kesalahan-Kesalahan) 1993 [*P.U. (A) 327/1993*] dipinda dalam Jadual Pertama dengan memasukkan selepas perenggan 20 perenggan yang berikut:

“21. Semua kesalahan di bawah Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan) (No. 3) 2021 [*P.U. (A) 64/2021*].

22. Semua kesalahan di bawah Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan Bersyarat) (No. 3) 2021 [*P.U. (A) 65/2021*].

23. Semua kesalahan di bawah Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan Pemulihan) (No. 2) 2021 [*P.U. (A) 66/2021*].”.

PREVENTION AND CONTROL OF INFECTIOUS DISEASES ACT 1988

PREVENTION AND CONTROL OF INFECTIOUS DISEASES
(COMPOUNDING OF OFFENCES) (AMENDMENT) (NO. 3) REGULATIONS 2021

IN exercise of the powers conferred by section 31 of the Prevention and Control of Infectious Diseases Act 1988 [Act 342], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Compounding of Offences) (Amendment) (No. 3) Regulations 2021**.

(2) These Regulations come into operation on 19 February 2021.

Amendment of First Schedule

2. The Prevention and Control of Infectious Diseases (Compounding of Offences) Regulations 1993 [*P.U. (A) 327/1993*] are amended in the First Schedule by inserting after paragraph 20 the following paragraphs:

“21. All offences under the Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) (No. 3) Regulations 2021 [*P.U. (A) 64/2021*].

22. All offences under the Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Conditional Movement Control) (No. 3) Regulations 2021 [*P.U. (A) 65/2021*].

23. All offences under the Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Recovery Movement Control) (No. 2) Regulations 2021 [*P.U. (A) 66/2021*].”.
