PADA menjalankan kuasa yang diberikan oleh subseksyen 11(2) Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan) (No. 2) (Pindaan) (No. 6) 2021**.

(2) Peraturan 2 mula berkuat kuasa pada 15 Februari 2021.

(3) Peraturan 3 mula berkuat kuasa pada 12 Februari 2021.

PREVENTION AND CONTROL OF INFECTIOUS DISEASES ACT 1988

PREVENTION AND CONTROL OF INFECTIOUS DISEASES
(MEASURES WITHIN INFECTED LOCAL AREAS) (MOVEMENT CONTROL) (NO. 2)
(AMENDMENT) (NO. 6) REGULATIONS 2021

IN exercise of the powers conferred by subsection 11(2) of the Prevention and Control of Infectious Diseases Act 1988 [*Act 342*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) (No. 2) (Amendment) (No. 6) Regulations 2021**.

(2) Regulation 2 comes into operation on 15 February 2021.

(3) Regulation 3 comes into operation on 12 February 2021.

Substitution of First Schedule

2. The Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) (No. 2) Regulations 2021 [*P.U. (A) 21/2021*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for the First Schedule the following schedule:
