PERATURAN-PERATURAN PENCEGAHAN DAN PENGAWALAN PENYAKIT BERJANGKIT
(LANGKAH-LANGKAH DI DALAM KAWASAN TEMPATAN JANGKITAN)
(KAWALAN PERGERAKAN) (PINDAAN) 2021

PADA menjalankan kuasa yang diberikan oleh subseksyen 11(2) Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan) (Pindaan) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 16 Januari 2021.

Pindaan peraturan 1

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Langkah-Langkah di dalam Kawasan Tempatan Jangkitan) (Kawalan Pergerakan) 2021 [*P.U. (A) 8/2021*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan 1(2), dengan menggantikan perkataan “Peraturan-Peraturan ini” dengan perkataan “Tertakluk kepada subperaturan 2(2), Peraturan-Peraturan ini”.

Pindaan peraturan 2

3. Peraturan 2 Peraturan-Peraturan ibu dipinda—

(a) dengan menomborkan semula peraturan 2 yang sedia ada sebagai subperaturan (1);

(b) dalam subperaturan (1) yang dinomborkan semula, dengan memasukkan selepas perkataan “Johor,” perkataan “Kelantan,”; dan

- (c) dengan memasukkan selepas subperaturan (1) yang dinomborkan semula subperaturan yang berikut:

“(2) Peraturan-Peraturan ini hendaklah terpakai bagi daerah Sibul, Sarawak bagi tempoh mulai 16 Januari 2021 hingga 29 Januari 2021.”.

Penggantian Jadual

4. Peraturan-Peraturan ibu dipinda dengan menggantikan Jadual dengan jadual yang berikut:

PREVENTION AND CONTROL OF INFECTIOUS DISEASES ACT 1988

PREVENTION AND CONTROL OF INFECTIOUS DISEASES
(MEASURES WITHIN INFECTED LOCAL AREAS) (MOVEMENT CONTROL)
(AMENDMENT) REGULATIONS 2021

IN exercise of the powers conferred by subsection 11(2) of the Prevention and Control of Infectious Diseases Act 1988 [*Act 342*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) (Amendment) Regulations 2021**.

(2) These Regulations come into operation on 16 January 2021.

Amendment of regulation 1

2. The Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (Movement Control) Regulations 2021 [*P.U. (A) 8/2021*], which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 1(2), by substituting for the words “These Regulations” the words “Subject to subregulation 2(2), these Regulations”.

Amendment of regulation 2

3. Regulation 2 of the principal Regulations is amended—

(a) by renumbering the existing regulation 2 as subregulation (1);

(b) in subregulation (1) as renumbered, by inserting after the words “Johore,” the words “Kelantan,”; and

(c) by inserting after subregulation (1) as renumbered the following subregulation:

“(2) These Regulations shall apply to the district of Sibu, Sarawak for the period from 16 January 2021 to 29 January 2021.”.

Substitution of Schedule

4. The principal Regulations are amended by substituting for the Schedule the following schedule:

32. Agricultural, fishery and husbandry including veterinary services
33. Farm, swiftlet bird nest, horse farm, animal processing plant, slaughterhouse, livestock, livestock food factory, pet shop management
