AKTA FUNGSI-FUNGSI MENTERI 1969

PERINTAH MENTERI-MENTERI KERAJAAN PERSEKUTUAN (NO. 3) (PINDAAN)
(NO. 2) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Fungsi-Fungsi Menteri 1969 [*Akta 2*], Yang di-Pertuan Agong membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (No. 3) (Pindaan) (No. 2) 2020**.

(2) Subperenggan 2(*a*) dan (*b*) disifatkan telah mula berkuat kuasa pada 21 Oktober 2020.

(3) Subperenggan 2(*c*) disifatkan telah mula berkuat kuasa pada 28 September 2020.

Pindaan Jadual

2. Perintah Menteri-Menteri Kerajaan Persekutuan (No. 3) 2020 [*P.U. (A) 201/2020*] dipinda dalam Jadual—

(*a*) berkenaan dengan Kementerian Sumber Manusia, dengan memotong butiran “Lembaga Teknologis Malaysia” dan “Akta Teknologis dan Juruteknik 2015 [*Akta 768*]” dalam ruang “*Jabatan/Perkara*”;

(*b*) berkenaan dengan Kementerian Sains, Teknologi dan Inovasi—

(i) dengan memasukkan selepas butiran “Malaysian Technology Development Corporation (MTDC)” dalam ruang “*Jabatan/Perkara*” butiran “Lembaga Teknologis Malaysia”; dan

- (c) berkenaan dengan Kementerian Pelancongan, Seni dan Budaya—
- (i) dengan memotong perkataan “Datuk Dr. Jeffrey G. Kitingan” dalam ruang “*Nama*”; dan
 - (ii) dengan memotong perkataan “Timbalan Menteri Pelancongan, Seni dan Budaya/10 Mac 2020” dalam ruang “*Gelaran dan Nama Jawatan/Tarikh Pelantikan*”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (NO. 3) (AMENDMENT) ORDER
(NO. 2) 2020

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Ministers of the Federal Government (No. 3) (Amendment) (No. 2) Order 2020**.

(2) Subparagraphs 2(a) and (b) are deemed to have come into operation on 21 October 2020.

(3) Subparagraph 2(c) is deemed to have come into operation on 28 September 2020.

Amendment of Schedule

2. The Ministers of the Federal Government Order (No. 3) 2020 [*P.U. (A) 201/2020*] is amended in the Schedule—

(a) in respect of the Ministry of Human Resources, by deleting the items “Malaysia Board of Technologists” and “Technologists and Technicians Act 2015 [Act 768]” in the “*Department/Subject*” column;

(b) in respect of the Ministry of Science, Technology and Innovation—

(i) by inserting after the item “Malaysian Technology Development Corporation (MTDC)” in the “*Department/Subject*” column the item “Malaysia Board of Technologists”; and

(ii) by inserting after the item “Agensi Inovasi Malaysia Act 2010 [Act 718]” in the “*Department/Subject*” column the item “Technologists and Technicians Act 2015 [Act 768]”; and

- (c) in respect of the Ministry of Tourism, Arts and Culture—
- (i) by deleting the words “Datuk Dr. Jeffrey G. Kitingan” in the “*Person*” column; and
 - (ii) by deleting the words “Deputy Minister of Tourism, Arts and Culture/10 March 2020” in the “*Style and Title/Date of Appointment*” column.
