AKTA IMIGRESEN 1959/63

PERINTAH IMIGRESEN (PENGECCUALIAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Imigresen 1959/63 [*Akta 155*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Imigresen (Pengeccualian) 2020**.

(2) Perintah ini mula berkuat kuasa pada 30 Disember 2020.

2. Menteri mengeccualikan pemegang Pas Lawatan daripada pemakaian seksyen 33 Akta berhubung dengan mana-mana Pas Lawatan yang telah habis tempoh dengan syarat bahawa suatu permohonan bagi Pas Lawatan itu telah dibuat dan menunggu kelulusan di bawah Peraturan-Peraturan Imigresen 1963 [*L.N. 228/1963*].

IMMIGRATION ACT 1959/63

IMMIGRATION (EXEMPTION) ORDER 2020

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [*Act 155*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Immigration (Exemption) Order 2020**.
- (2) This Order comes into operation on 30 December 2020.

Exemption

2. The Minister exempts a Visit Pass holder from the application of section 33 of the Act in relation to any Visit Pass which has expired provided that an application for the Visit Pass has been made and pending approval under the Immigration Regulations 1963 [*L.N. 228/1963*].
