AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 11) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Kedah, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 11) 2020**.

(2) Perintah ini mula berkuat kuasa pada 24 Disember 2020.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama—

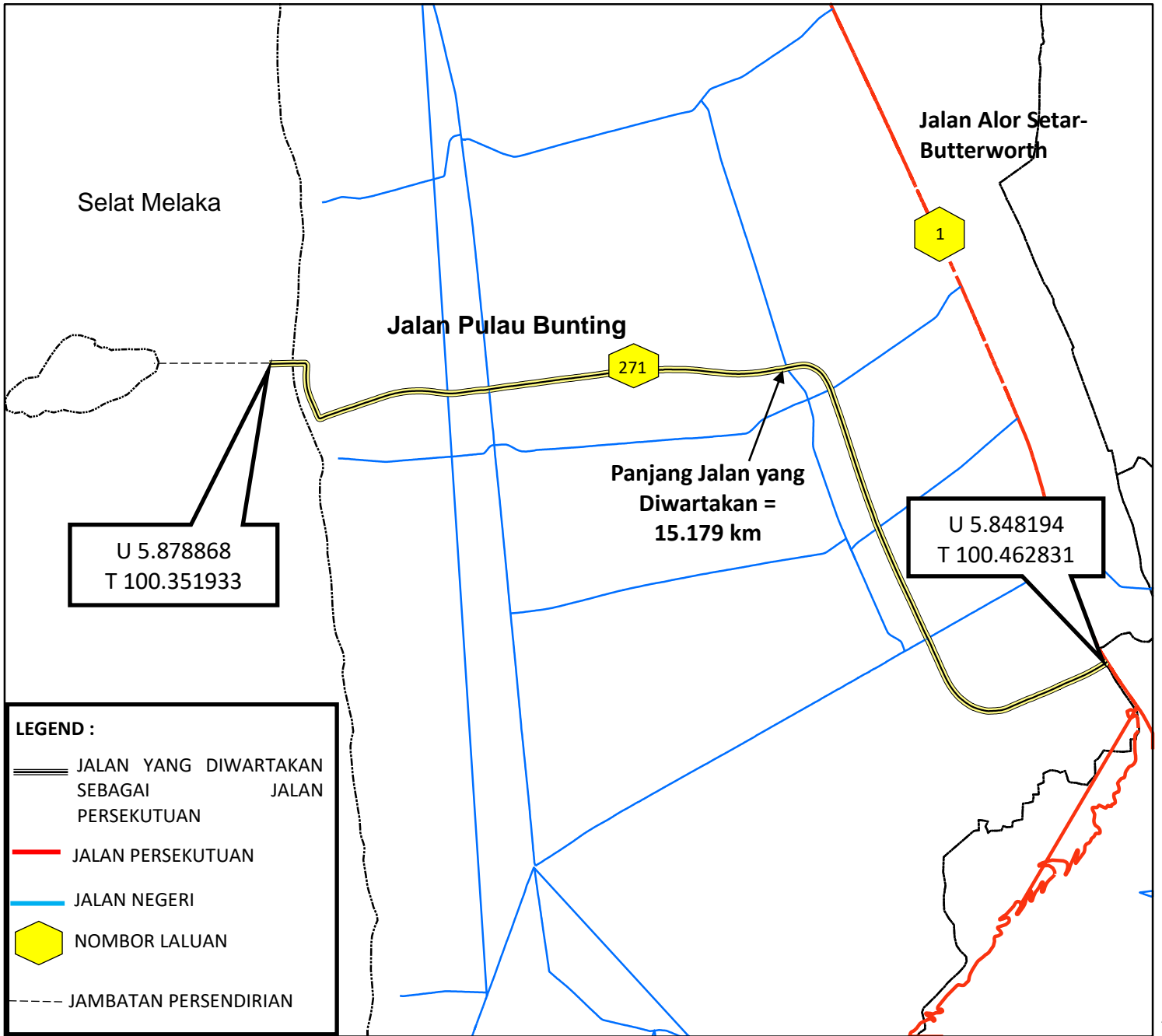
(a) di bawah kepala “**Negeri Kedah Darul Aman**” dengan memasukkan selepas butiran 65 butiran yang berikut:

“66. (*Laluan 271*): *Jalan Pulau Bunting*

Bermula dari persimpangan Laluan 1, Jalan Alor Setar—Butterworth di koordinat U 5.848194, T 100.462831 dan berakhir di koordinat U 5.878868, T 100.351933 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA: JALAN PULAU BUNTING (jarak sepanjang 15.179 km).”; dan

(b) dengan memasukkan selepas PETA: JALAN SUNGAI LAYAR—SEMELING peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 11) ORDER 2020

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Kedah, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 11) Order 2020**.

(2) This Order comes into operation on 24 December 2020.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule—

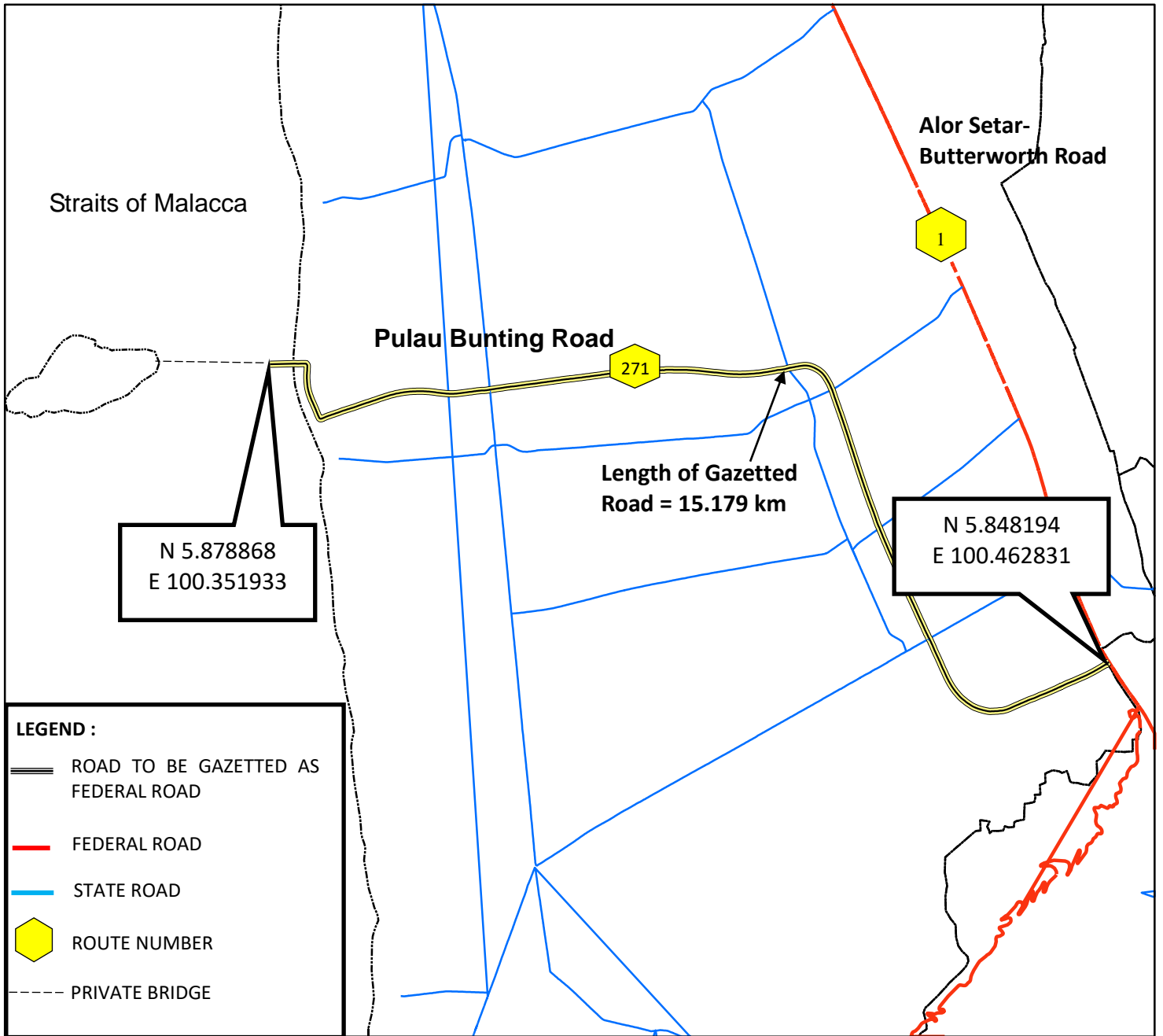
(a) under the heading of “**Negeri Kedah Darul Aman**” by inserting after item 65 the following item:

“66. *(Route 271): Pulau Bunting Road*

Starting from the junction of Route 1, Alor Setar—Butterworth Road at coordinates N 5.848194, E 100.462831 and ending at coordinates N 5.878868, E 100.351933 within the boundaries of right of way as shown on MAP: PULAU BUNTING ROAD (a distance of 15.179 km).”;
and

(b) by inserting after MAP: SUNGAI LAYAR—SEMELING ROAD the following map:
