AKTA RACUN MAKHLUK PEROSAK 1974

PERINTAH RACUN MAKHLUK PEROSAK (PENGECCUALIAN) (NO. 6) 2020

PADA menjalankan kuasa yang diberi oleh seksyen 59 Akta Racun Makhluk Perosak 1974 [*Akta 149*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Racun Makhluk Perosak (Pengeccualian) (No. 6) 2020**.

(2) Perintah ini mula berkuat kuasa pada 1 Disember 2020.

Pengeccualian

2. Menteri mengeccualikan SOUTHERN INDUSTRIAL GAS SDN. BHD. (No. Syarikat 380462-X) daripada larangan di bawah perenggan 13(1)(b) Akta bagi maksud mengimport sesuatu racun makhluk perosak yang mengandungi ethylene oxide sebagai perawis aktifnya.

Syarat pengeccualian

3. Pengeccualian di bawah perenggan 2 adalah tertakluk kepada syarat bahawa racun makhluk perosak yang diimport itu hendaklah digunakan semata-mata bagi pensterilan peranti perubatan.

PESTICIDES ACT 1974

PESTICIDES (EXEMPTION) (NO. 6) ORDER 2020

IN exercise of the powers conferred by section 59 of the Pesticides Act 1974 [*Act 149*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Pesticides (Exemption) (No. 6) Order 2020**.

(2) This Order comes into operation on 1 December 2020.

Exemption

2. The Minister exempts SOUTHERN INDUSTRIAL GAS SDN. BHD. (Company No. 380462-X) from the prohibition under paragraph 13(1)(b) of the Act for the purpose of importing a pesticide containing ethylene oxide as its active ingredient.

Condition of exemption

3. The exemption under paragraph 2 is subject to the condition that the imported pesticide shall be used solely for the sterilization of medical devices.
