CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 6) ORDER 2020

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

Citation

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 6) Order 2020**.

Controlled articles

2. The articles specified in the Schedule are declared to be controlled articles for the period from 9 November 2020 to 17 November 2020.
