PADA menjalankan kuasa yang diberikan oleh seksyen 31 Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompunan Kesalahan-Kesalahan) (Pindaan) (No. 12) 2020**.

Pindaan Jadual Pertama

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompunan Kesalahan-Kesalahan) 1993 [*P.U. (A) 327/1993*] dipinda dalam Jadual Pertama dengan memasukkan selepas perenggan 1A perenggan yang berikut:

“1B. Perenggan 22(*b*) ... Keengganan seseorang yang dijangkiti atau seseorang yang pegawai diberi kuasa percaya telah dijangkiti untuk mematuhi apa-apa arahan, perintah atau kehendak yang diberikan di bawah seksyen 14 untuk menyebabkan pemindahan atau penahanan orang yang dijangkiti atau dipercayai telah dijangkiti itu.

1C. Perenggan 22(*b*) ... Enggan mematuhi apa-apa perintah pegawai diberi kuasa di bawah seksyen 15.”

PREVENTION AND CONTROL OF INFECTIOUS DISEASES ACT 1988

PREVENTION AND CONTROL OF INFECTIOUS DISEASES
(COMPOUNDING OF OFFENCES) (AMENDMENT) (NO. 12) REGULATIONS 2020

IN exercise of the powers conferred by section 31 of the Prevention and Control of Infectious Diseases Act 1988 [*Act 342*], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Prevention and Control of Infectious Diseases (Compounding of Offences) (Amendment) (No. 12) Regulations 2020**.

Amendment of First Schedule

2. The Prevention and Control of Infectious Diseases (Compounding of Offences) Regulations 1993 [*P.U. (A) 327/1993*] are amended in the First Schedule by inserting after paragraph 1A the following paragraphs:

“1B. Paragraph 22(*b*) ... Refusal of an infected person or a person whom an authorized officer believes to be infected to comply with any direction, order or requisition given under section 14 to cause the removal or detention of such person who has been infected or believed to have been infected.

1C. Paragraph 22(*b*) ... Refusing to comply with any order of an authorized officer under section 15.”.
