**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompanaan Kesalahan-Kesalahan) (Pindaan) (No. 11) 2020**.

**Pindaan Jadual Pertama**

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Pengkompanaan Kesalahan-Kesalahan) 1993 [*P.U. (A) 327/1993*] dipinda dalam Jadual Pertama dengan memasukkan selepas perenggan 1 perenggan yang berikut:

“1A. Subseksyen 11(5) ... Enggan mematuhi apa-apa arahan yang dikeluarkan oleh pegawai diberi kuasa di bawah subseksyen 11(3).”.

PREVENTION AND CONTROL OF INFECTIOUS DISEASES  
(COMPOUNDING OF OFFENCES) (AMENDMENT) (NO. 11) REGULATIONS 2020

IN exercise of the powers conferred by section 31 of the Prevention and Control of Infectious Diseases Act 1988 [Act 342], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Prevention and Control of Infectious Diseases (Compounding of Offences) (Amendment) (No. 11) Regulations 2020**.

**Amendment of First Schedule**

2. The Prevention and Control of Infectious Diseases (Compounding of Offences) Regulations 1993 [*P.U. (A) 327/1993*] are amended in the First Schedule by inserting after paragraph 1 the following paragraph:

“1A. Subsection 11(5) ... Refusing to comply with any direction issued by an authorized officer under subsection 11(3).”.
