AKTA PERKHIDMATAN BOMBA 1988

PERATURAN-PERATURAN PERKHIDMATAN BOMBA  
(PENGKOMPANAN KESALAHAN) (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh perenggan 62(1)(n) Akta Perkhidmatan Bomba 1988 [*Akta 341*], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkhidmatan Bomba (Pengkompunan Kesalahan) (Pindaan) 2020**.

**Penggantian peraturan 2**

2. Peraturan-Peraturan Perkhidmatan Bomba (Perkompunan Kesalahan) 2000 [*P.U. (A) 313/2000*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan peraturan 2 dengan peraturan yang berikut:

**“Kesalahan yang boleh dikompaun**

2. Kesalahan-kesalahan yang berikut ditetapkan sebagai kesalahan yang boleh dikompaun:

(a) kesalahan di bawah subseksyen 23(4) dan 25(2) dan seksyen 26, 47, 52 dan 55 Akta; dan

(b) kesalahan di bawah subperaturan 3(5), 5(3) dan 6(2) Peraturan-Peraturan Bomba (Perakuan Bomba) 2001 [*P.U. (A) 241/2001*].”.

**Pindaan Jadual**

3. Peraturan-Peraturan ibu dipinda dalam Jadual—
- (a) di bawah kepala “#Seksyen/Subseksyen”, dengan memotong ruang 51; dan
  - (b) di bawah kepala “Kesalahan Di Bawah Akta”, dengan memotong seksyen 51 dan butir-butir yang berhubungan dengannya.

FIRE SERVICES ACT 1988

FIRE SERVICES (COMPOUNDING OF OFFENCES)  
(AMENDMENT) REGULATIONS 2020

IN exercise of the powers conferred by paragraph 62(1)(n) of the Fire Services Act 1988 [Act 341], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Fire Services (Compounding of Offences) (Amendment) Regulations 2020**.

**Substitution of regulation 2**

2. The Fire Services (Compounding of Offences) Regulations 2000 [P.U. (A) 313/2000], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for regulation 2 the following regulation:

**“Compoundable offences**

2. The following offences are prescribed to be compoundable offences:

- (a) offences under subsections 23(4) and 25(2) and sections 26, 47, 52 and 55 of the Act; and
- (b) offences under subregulations 3(5), 5(3) and 6(2) of the Fire Services (Fire Certificate) Regulations 2001 [P.U. (A) 241/2001].”.

**Amendment of Schedule**

3. The principal Regulations are amended in the Schedule—
- (a) under the heading “#Section/Subsection”, by deleting column 51; and
  - (b) under the heading “Offences Under The Act”, by deleting section 51 and the particulars relating to it.
