PERATURAN-PERATURAN MATA WANG (FI PEMROSESAN BAGI PERMOHONAN
PENDAFTARAN PERNIAGAAN PEMROSESAN MATA WANG) 2020

PADA menjalankan kuasa yang diberikan oleh perenggan 25(1)(c) dan 60(2)(a) Akta Mata Wang 2020 [*Akta 827*], Menteri, atas syor Bank, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Mata Wang (Fi Pemprosesan bagi Permohonan Pendaftaran Perniagaan Pemprosesan Mata Wang) 2020**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Oktober 2020.

CURRENCY ACT 2020

CURRENCY (PROCESSING FEES FOR APPLICATION OF REGISTRATION OF CURRENCY
PROCESSING BUSINESS) REGULATIONS 2020

IN exercise of the powers conferred by paragraphs 25(1)(c) and 60(2)(a) of the Currency Act 2020 [Act 827], the Minister, on the recommendation of the Bank, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Currency (Processing Fees for Application of Registration of Currency Processing Business) Regulations 2020**.

(2) These Regulations come into operation on 1 October 2020.

Processing fees

2. The processing fees payable for an application for registration to carry on currency processing business under paragraph 25(1)(c) of the Act is five hundred ringgit.
