PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA (PERBEKALAN) 2020

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) 2020**.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (SUPPLY) REGULATIONS 2020

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employees' Social Security (Supply) Regulations 2020**.

Issue for expenditure for the year 2020

2. The issue of a sum not exceeding eight hundred and ninety-seven million eight hundred and twenty-two thousand ringgit (RM897,822,000) from the Social Security Fund for the expenditure on administration of the Scheme of Social Security for the year 2020 is hereby authorized for the purposes specified in the Schedule.
