PERATURAN-PERATURAN SISTEM INSURANS PEKERJAAN (PERBEKALAN) 2020

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Sistem Insurans Pekerjaan (Perbekalan) 2020**.

EMPLOYMENT INSURANCE SYSTEM ACT 2017

EMPLOYMENT INSURANCE SYSTEM (SUPPLY) REGULATIONS 2020

IN exercise of the powers conferred by subsection 48(1) of the Employment Insurance System Act 2017 [Act 800], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employment Insurance System (Supply) Regulations 2020**.

Issue for expenditure for the year 2020

2. The issue of a sum not exceeding one hundred and eighty-one million eight hundred and twenty-four thousand ringgit (RM181,824,000) from the Employment Insurance System Fund for the expenditure on administration of the Employment Insurance System for the year 2020 is hereby authorized for the purposes specified in the Schedule.
