AKTA PENGURUSAN SISA PEPEJAL DAN PEMBERSIHAN AWAM 2007

PERATURAN-PERATURAN PENGURUSAN SISA PEPEJAL DAN PEMBERSIHAN AWAM
(PENGKOMPANAN KESALAHAN) (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 108 Akta Pengurusan Sisa Pepejal dan Pembersihan Awam 2007 [*Akta 672*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Pengkompunan Kesalahan) (Pindaan) 2020**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 September 2020.

2. Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Pengkompunan Kesalahan) 2011 [*P.U. (A) 309/2011*] dipinda dalam peraturan 2—

(a) dalam perenggan (b), dengan memasukkan selepas perkataan “Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Skim bagi Sisa Pepejal Isi Rumah dan Sisa Pepejal yang Serupa dengan Sisa Pepejal Isi Rumah) 2011” perkataan “[*P.U. (A) 307/2011*]”;

(b) dalam perenggan (c), dengan memasukkan selepas perkataan “Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Pelesenan) (Pengusahaan atau Penyediaan Perkhidmatan Pemungutan bagi Sisa Pepejal Isi Rumah, Sisa Pepejal Awam, Sisa Pepejal Keinstitutional Awam dan Sisa Pepejal yang Serupa dengan Sisa Pepejal Isi Rumah) 2011” perkataan “[*P.U. (A) 303/2011*]”;

- (c) dalam perenggan (d)—
- (i) dengan memasukkan selepas perkataan “Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Pelesenan) (Pengurusan atau Pengendalian Kemudahan Pengurusan Sisa Pepejal yang Ditetapkan) 2011” perkataan “[P.U. (A) 304/2011]”; dan
 - (ii) dengan memotong perkataan “dan” di hujung perenggan itu;
- (d) dalam perenggan (e)—
- (i) dengan memasukkan selepas perkataan “Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Pelesenan) (Pengusahaan atau Penyediaan Perkhidmatan Pengangkutan oleh Pengangkutan Jauh) 2011” perkataan “[P.U. (A) 305/2011]”; dan
 - (ii) dengan menggantikan noktah di hujung perenggan itu dengan koma bernoktah; dan
- (e) dengan memasukkan selepas perenggan (e) perenggan yang berikut:
- “(f) kesalahan di bawah subperaturan 5(2), 6(3), 7(2), 8(3), 9(4), 10(4), 11(2), 12(3), 13(6), 14(6), 15(5) dan 16(7) Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Skim Bagi Sisa Pepejal Komersial, Perindustrian dan Keinstitusian) 2018 [P.U. (A) 181/2018]; dan
 - (g) kesalahan di bawah subperaturan 4(3), 5(2), 6(3), 7(4), 8(4), 9(2), 10(3), 11(6), 12(6), 13(5) dan 14(7) Peraturan-Peraturan Pengurusan Sisa Pepejal dan Pembersihan Awam (Skim Bagi Sisa Pepejal Pembinaan) 2018 [P. U. (A) 279/2018].”.

SOLID WASTE AND PUBLIC CLEANSING MANAGEMENT ACT 2007

SOLID WASTE AND PUBLIC CLEANSING MANAGEMENT (COMPOUNDING OF OFFENCES) (AMENDMENT) REGULATIONS 2020

IN exercise of the powers conferred by section 108 of the Solid Waste and Public Cleansing Management Act 2007 [*Act 672*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations maybe cited as the **Solid Waste and Public Cleansing Management (Compounding of Offences) (Amendment) Regulations 2020**.

(2) These Regulations come into operation on 1 September 2020.

Amendment of regulation 2

2. The Solid Waste and Public Cleansing Management (Compounding of Offences) Regulations 2011 [*P.U. (A) 309/2011*] are amended in regulation 2—

(a) in paragraph (b), by inserting after the words “Solid Waste and Public Cleansing Management (Scheme for Household Solid Waste and Solid Waste Similar to Household Solid Waste) Regulations 2011” the words “[*P.U. (A) 307/2011*]”;

(b) in paragraph (c), by inserting after the words “Solid Waste and Public Cleansing Management (Licensing) (Undertaking or Provision of Collection Services for Household Solid Waste, Public Solid Waste, Public Institutional Solid Waste and Solid Waste Similar to Household Solid Waste) Regulations 2011” the words “[*P.U. (A) 303/2011*]”;

(c) in paragraph (d)—

(i) by inserting after the words “Solid Waste and Public Cleansing Management (Licensing) (Management or Operation of Prescribed

Solid Waste Management Facilities) Regulations 2011” the words “[P.U. (A) 304/2011]”; and

(ii) by deleting the word “and” at the end of the paragraph;

(d) in paragraph (e)—

(i) by inserting after the words “Solid Waste and Public Cleansing Management (Licensing) (Undertaking or Provision of Transportation Services by Long Haulage) Regulations 2011” the words “[P.U. (A) 305/2011]”; and

(ii) by substituting for the full stop at the end of the paragraph a semicolon; and

(e) by inserting after paragraph (e) the following paragraphs:

“(f) offences under subregulations 5(2), 6(3), 7(2), 8(3), 9(4), 10(4), 11(2), 12(3), 13(6), 14(6), 15(5) and 16(7) of the Solid Waste and Public Cleansing Management (Scheme for Commercial, Industrial and Institutional Solid Waste) Regulations 2018 [P.U. (A) 181/2018]; and

(g) offences under subregulations 4(3), 5(2), 6(3), 7(4), 8(4), 9(2), 10(3), 11(6), 12(6), 13(5) and 14(7) of the Solid Waste and Public Cleansing Management (Scheme for Construction Solid Waste) Regulations 2018 [P. U. (A) 279/2018].”.
