PADA menjalankan kuasa yang diberikan oleh perenggan 31(2)(p) Akta Pencegahan dan Pengawalan Penyakit Berjangkit 1988 [*Akta 342*], Menteri membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Fi bagi Ujian Pengesanan Penyakit Koronavirus 2019 (COVID-19)) (Pindaan) 2020**.

Pindaan peraturan 3

2. Peraturan-Peraturan Pencegahan dan Pengawalan Penyakit Berjangkit (Fi bagi Ujian Pengesanan Penyakit Koronavirus 2019 (COVID-19)) 2020 [*P.U. (A) 190/2020*] dipinda dalam peraturan 3 dengan menggantikan subperaturan (1) dengan subperaturan yang berikut:

“(1) Mana-mana orang, termasuk mana-mana warganegara dan orang asing yang memasuki Malaysia dari luar negara, yang telah diarahkan oleh pegawai diberi kuasa untuk menjalani ujian pengesanan COVID-19 hendaklah membayar fi yang dinyatakan dalam ruang (2) atau (3) Jadual, mengikut mana-mana yang berkenaan, berhubung dengan jenis ujian pengesanan COVID-19 yang dinyatakan dalam ruang (1) sebagaimana yang ditentukan di bawah peraturan 4.”.

PREVENTION AND CONTROL OF INFECTIOUS DISEASES
(FEE FOR CORONAVIRUS DISEASE 2019 (COVID-19) DETECTION TEST)
(AMENDMENT) REGULATIONS 2020

IN exercise of the powers conferred by paragraph 31(2)(p) of the Prevention and Control of Infectious Diseases Act 1988 [Act 342], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Prevention and Control of Infectious Diseases (Fee for Coronavirus Disease 2019 (COVID-19) Detection Test) (Amendment) Regulations 2020**.

Amendment of regulation 3

2. Prevention and Control of Infectious Diseases (Fee for Coronavirus Disease 2019 (COVID-19) Detection Test) Regulations 2020 [P.U. (A) 190/2020] are amended in regulation 3 by substituting for subregulation (1) the following subregulation:

“(1) Any person, including any citizen and foreigner entering Malaysia from overseas, who has been instructed by an authorized officer to undergo COVID-19 detection test shall pay the fee specified in column (2) or (3) of the Schedule, as the case may be, relating to the type of COVID-19 detection test specified in column (1) as determined under regulation 4.”.
