PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 5) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 5) 2020**.

(2) Perintah ini mula berkuat kuasa pada 27 Julai 2020.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Pahang Darul Makmur**" —

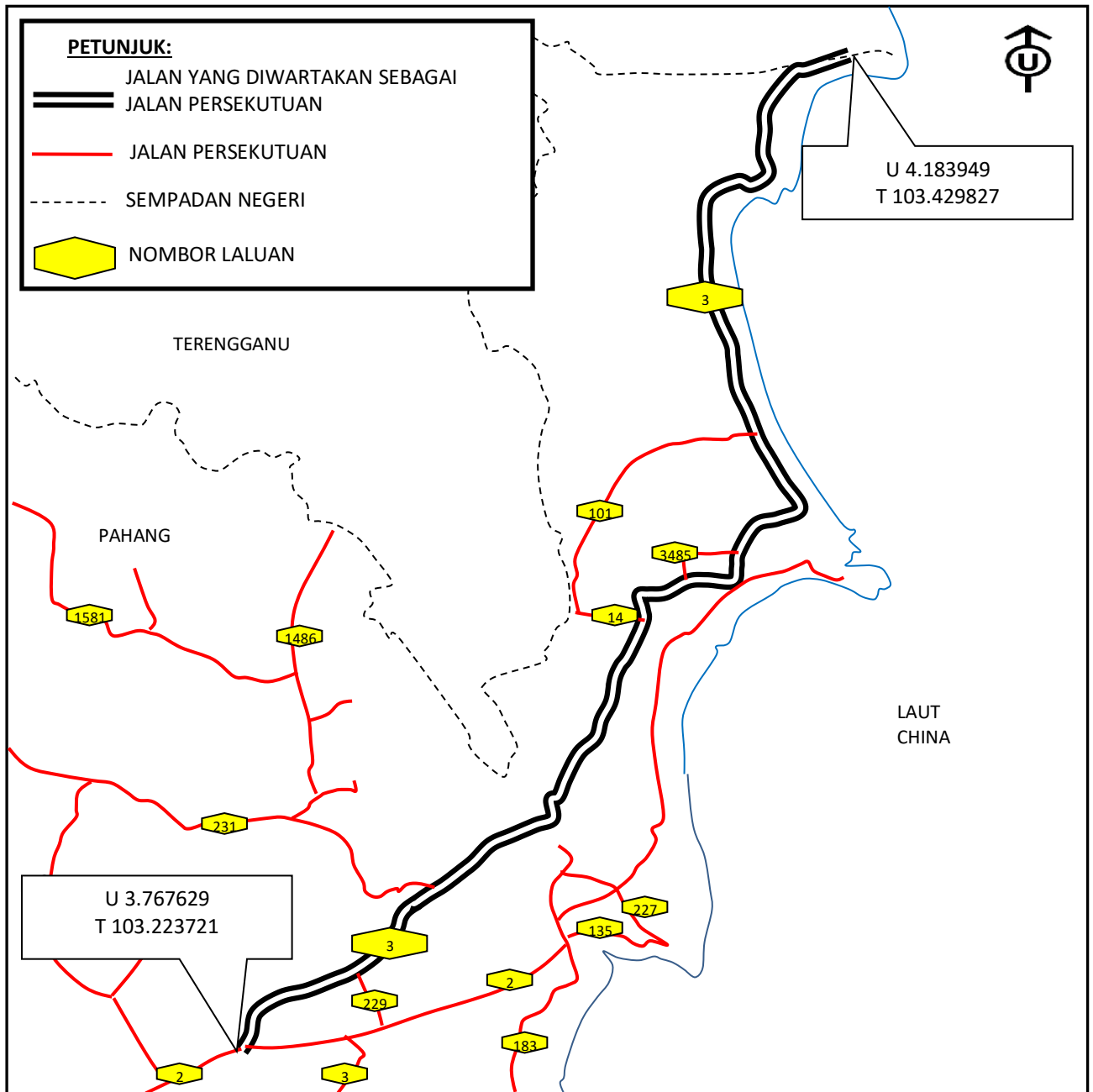
(a) dengan menggantikan butiran 3 dengan butiran yang berikut:

"3. *(Laluan 3): Jalan Kuantan-Cukai*

Dari persimpangannya dengan Laluan 2 Jalan Kuala Lumpur-Kuantan di koordinat U 3.767629, T 103.223721 ke sempadan negeri Pahang-Terengganu di koordinat U 4.183949, T 103.429827 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 27: JALAN KUANTAN-CUKAI, NEGERI PAHANG (jarak sepanjang 60.59 km)."; dan

(b) dengan memasukkan selepas PETA 26: JALAN CENTRAL SPINE, NEGERI PAHANG peta yang berikut:

“PETA 27: JALAN KUANTAN-CUKAI, NEGERI PAHANG

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 5) ORDER 2020

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 5) Order 2020**.

(2) This Order comes into operation on 27 July 2020.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “**Negeri Pahang Darul Makmur**”—

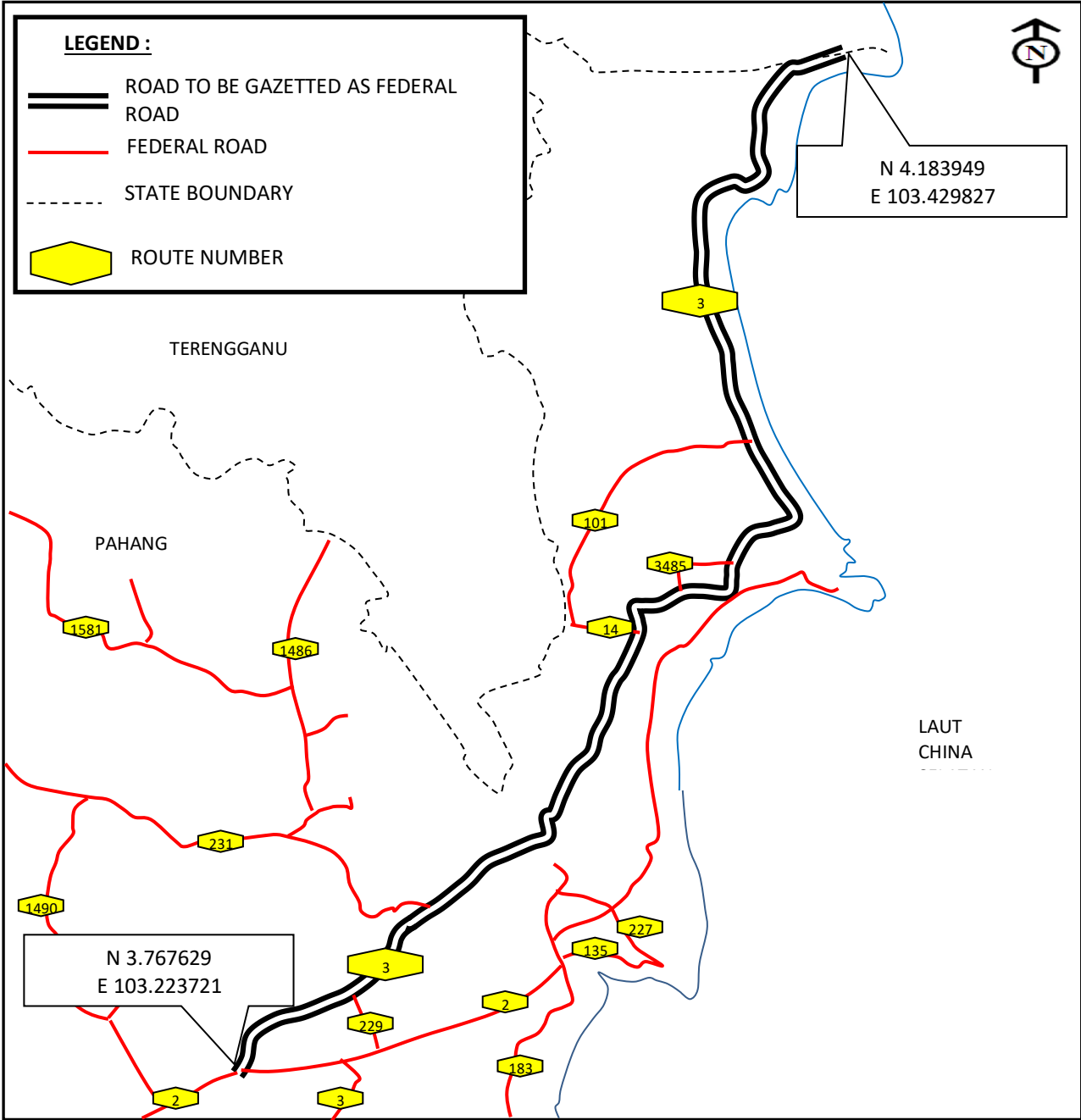
(a) by substituting for item 3 the following item:

“3. *(Route 3): Kuantan-Cukai Road*

From its junction with Route 2 Kuala Lumpur-Kuantan Road at coordinates N 3.767629, E 103.223721 to Pahang-Terengganu state boundary at coordinates N 4.183949, E 103.429827 within the boundaries of right of way as shown on MAP 27: KUANTAN-CUKAI ROAD, NEGERI PAHANG (a distance of 60.59 km).”; and

(b) by inserting after MAP 26: CENTRAL SPINE ROAD, NEGERI PAHANG the following map:
