AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 4) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Pahang dan Kelantan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 4) 2020**.

(2) Perintah ini mula berkuat kuasa pada 22 Julai 2020.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama –

(a) di bawah kepala “**Negeri Pahang Darul Makmur**”–

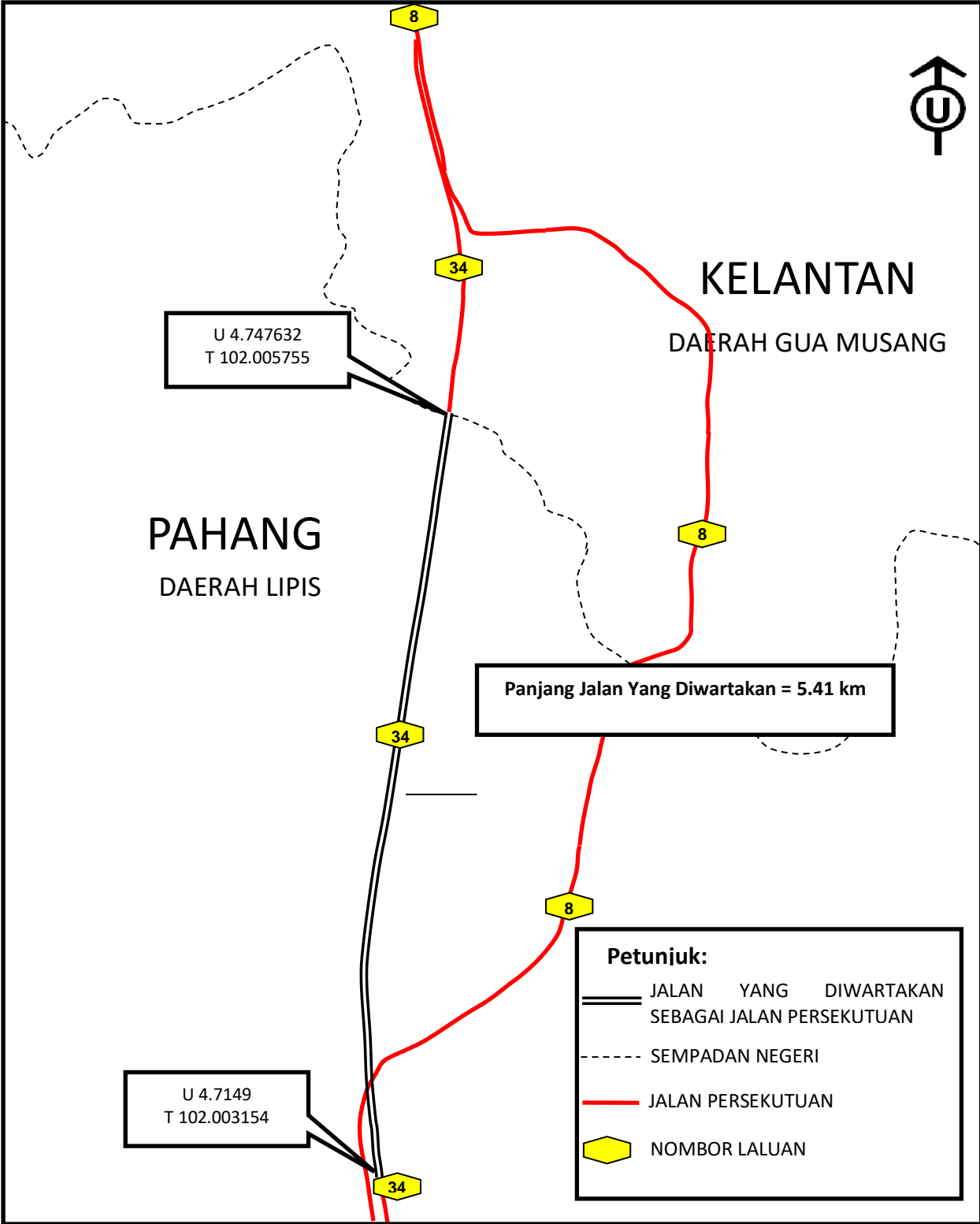
(i) dengan memasukkan selepas butiran 47 butiran yang berikut:

“48. (*Laluan 34*): *Jalan Central Spine*

Bermula dari Merapoh di koordinat U 4.7149, T 102.003154 dan berakhir di sempadan negeri Pahang-Kelantan di koordinat U 4.747632, T 102.005755 di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA 26: JALAN CENTRAL SPINE, NEGERI PAHANG (jarak sepanjang 5.41 km).”; dan

(ii) dengan memasukkan selepas PETA 25: JALAN CHEROK PALOH, NEGERI PAHANG peta yang berikut:

“PETA 26: JALAN CENTRAL SPINE, NEGERI PAHANG



”; dan

(b) di bawah kepala “**Negeri Kelantan Darul Naim**”–

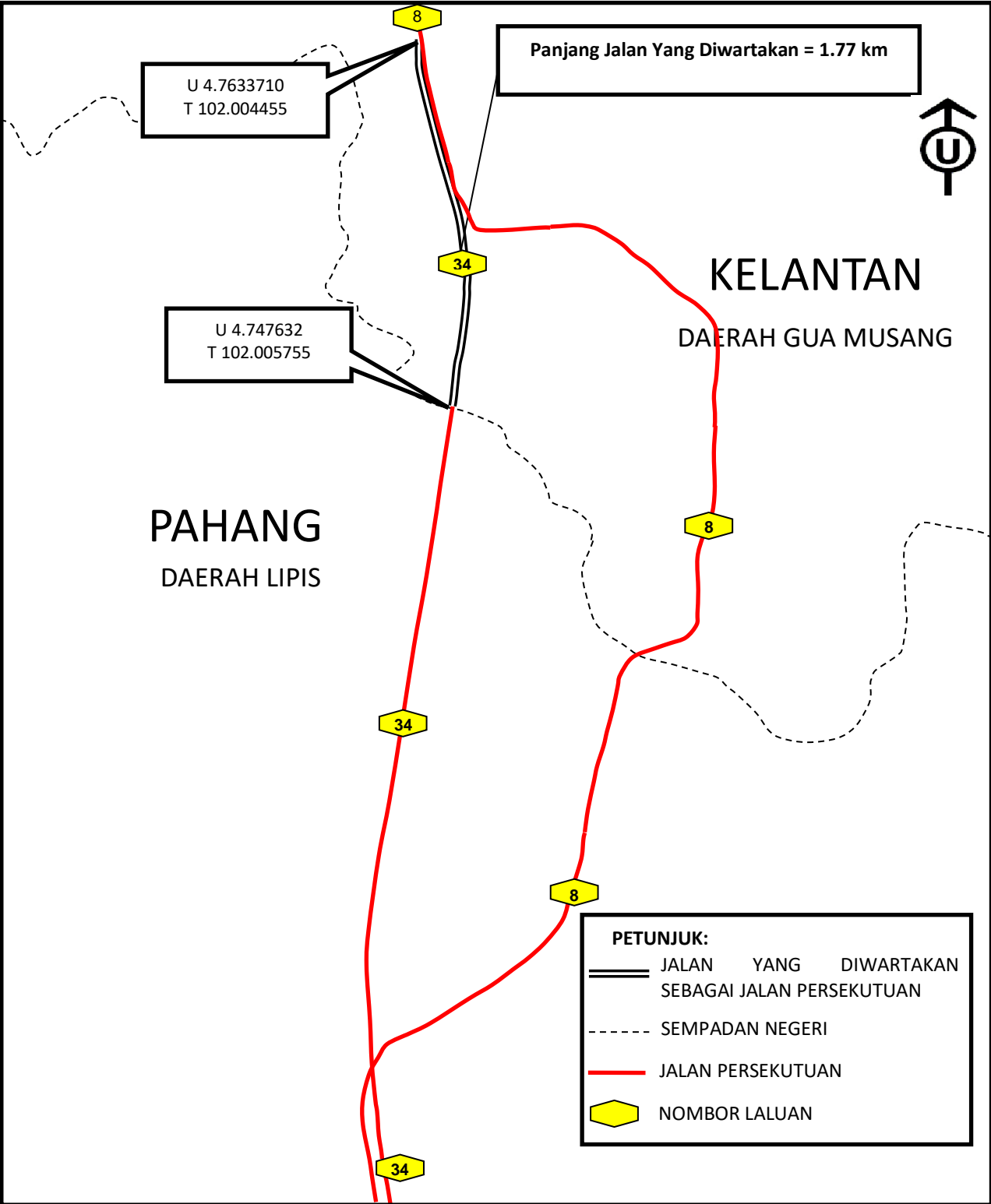
(i) dengan memasukkan selepas butiran 43 butiran yang berikut:

“44. *(Laluan 34): Jalan Central Spine*

Bermula dari sempadan negeri Pahang-Kelantan di koordinat U 4.747632, T 102.005755 dan berakhir di koordinat U 4.7633710, T 102.004455 di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA 18: JALAN CENTRAL SPINE, NEGERI KELANTAN (jarak sepanjang 1.77 km).”; dan

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 4) ORDER 2020

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Governments of Pahang and Kelantan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 4) Order 2020**.

(2) This Order comes into operation on 22 July 2020.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule–

(a) under the heading of “**Negeri Pahang Darul Makmur**”–

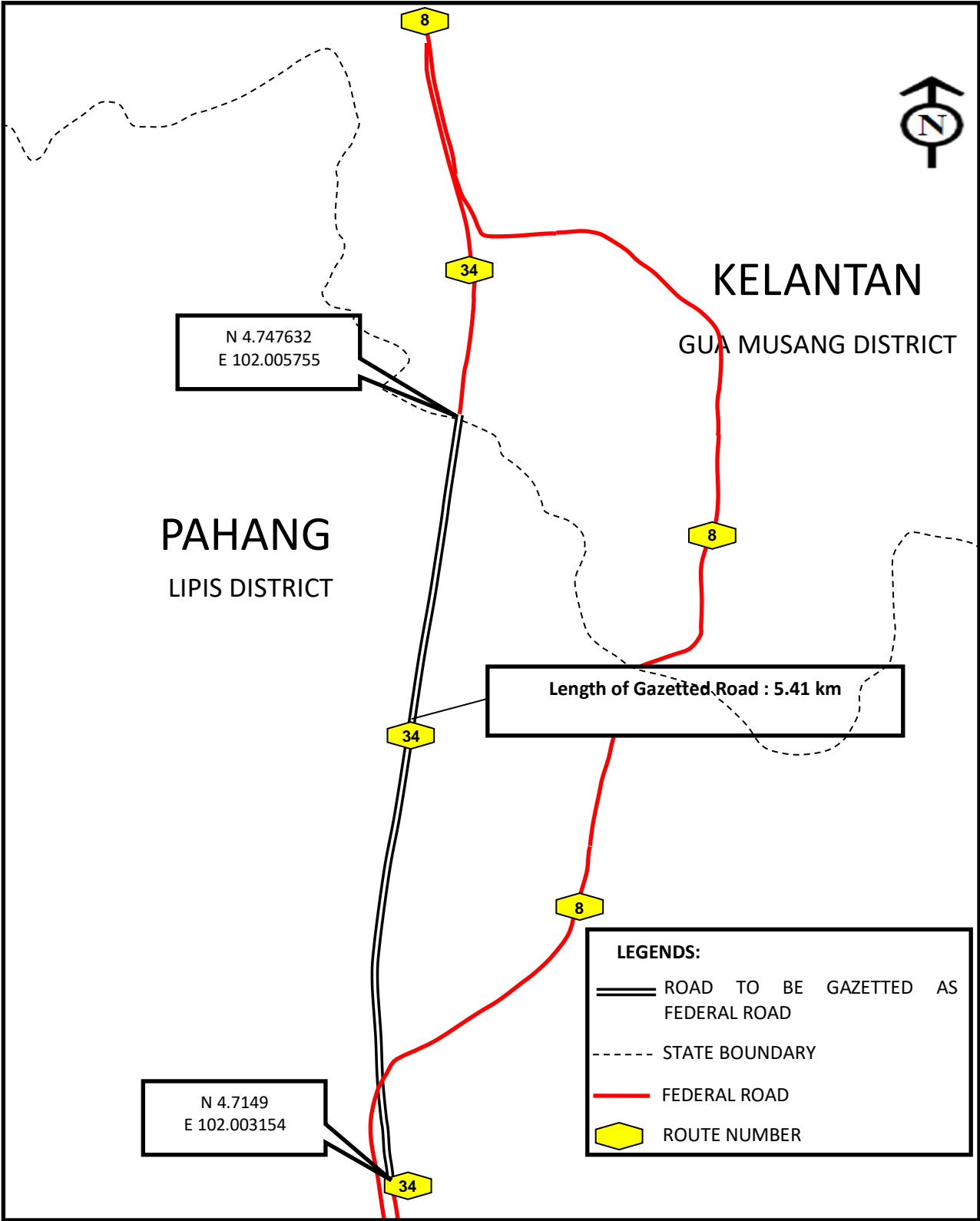
(i) by inserting after item 47 the following item:

“48. *(Route 34): Central Spine Road*

Starting from Merapoh at coordinates N 4.7149, E 102.003154 and ending at Pahang-Kelantan boundary at coordinates N 4.747632, E 102.005755 within the boundaries of right of way as shown on MAP 26: CENTRAL SPINE ROAD, NEGERI PAHANG (a distance of 5.41 km).”;
and

(ii) by inserting after MAP 25: CHEROK PALOH ROAD, NEGERI PAHANG the following map:

“MAP 26: CENTRAL SPINE ROAD, NEGERI PAHANG



”; and

(b) under the heading of “**Negeri Kelantan Darul Naim**”–

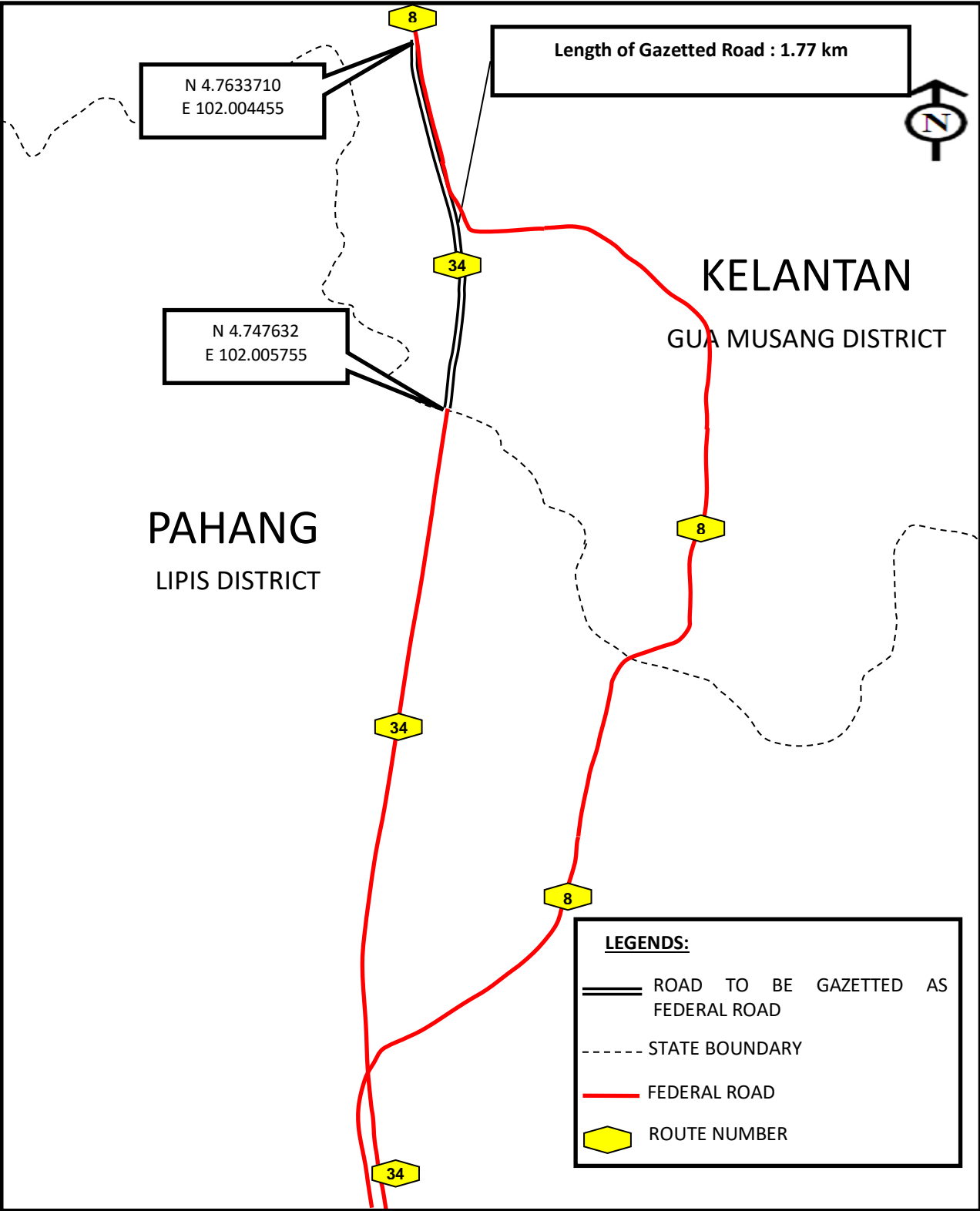
(i) by inserting after item 43 the following item:

“44. *(Route 34): Central Spine Road*

Starting from Pahang-Kelantan boundary at coordinates N 4.747632, E 102.005755 and ending at coordinates N 4.7633710, E 102.004455 within the boundaries of right of way as shown on MAP 18: CENTRAL SPINE ROAD, NEGERI KELANTAN (a distance of 1.77 km).”; and

(ii) by inserting after MAP 17: WAKAF BHARU-PALEKBANG ROAD the following map:
