PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 3) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Kelantan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 3) 2020**.

(2) Perintah ini mula berkuat kuasa pada 18 Julai 2020.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Kelantan Darul Naim**"—

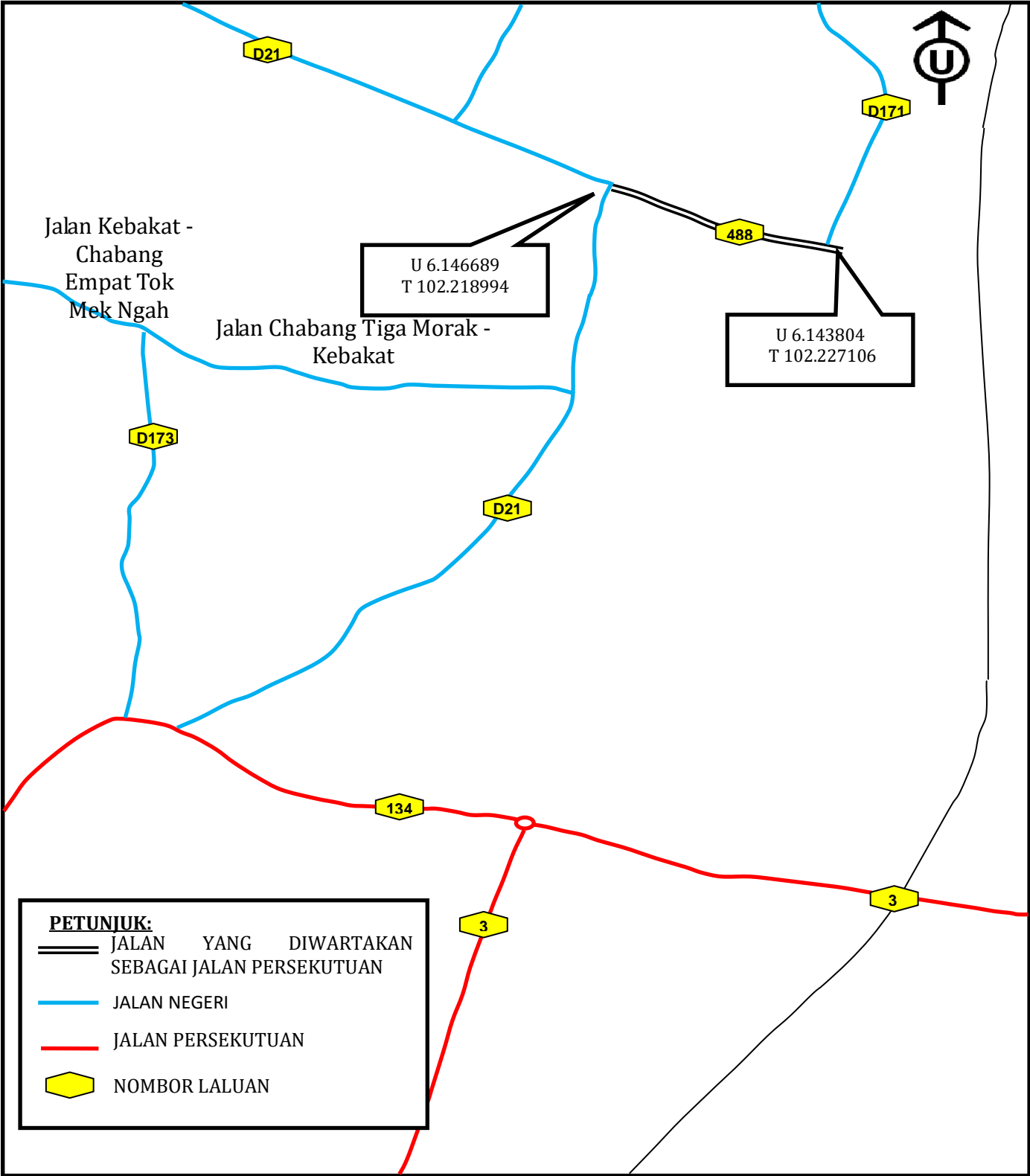
(a) dengan memasukkan selepas butiran 42 butiran yang berikut:

"43. *(Laluan 488): Jalan Wakaf Bharu-Palekbang*

Dari persimpangannya dengan Laluan D21 di koordinat U 6.146689, T 102.218994 dan berakhir di koordinat U 6.143804, T 102.227106 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 17: JALAN WAKAF BHARU-PALEKBANG (jarak sepanjang 0.94 km)."; dan

(b) dengan memasukkan selepas PETA 16: JALAN KADOK KE KETEREH peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 3) ORDER 2020

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Kelantan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 3) Order 2020**.

(2) This Order comes into operation on 18 July 2020.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “**Negeri Kelantan Darul Naim**”—

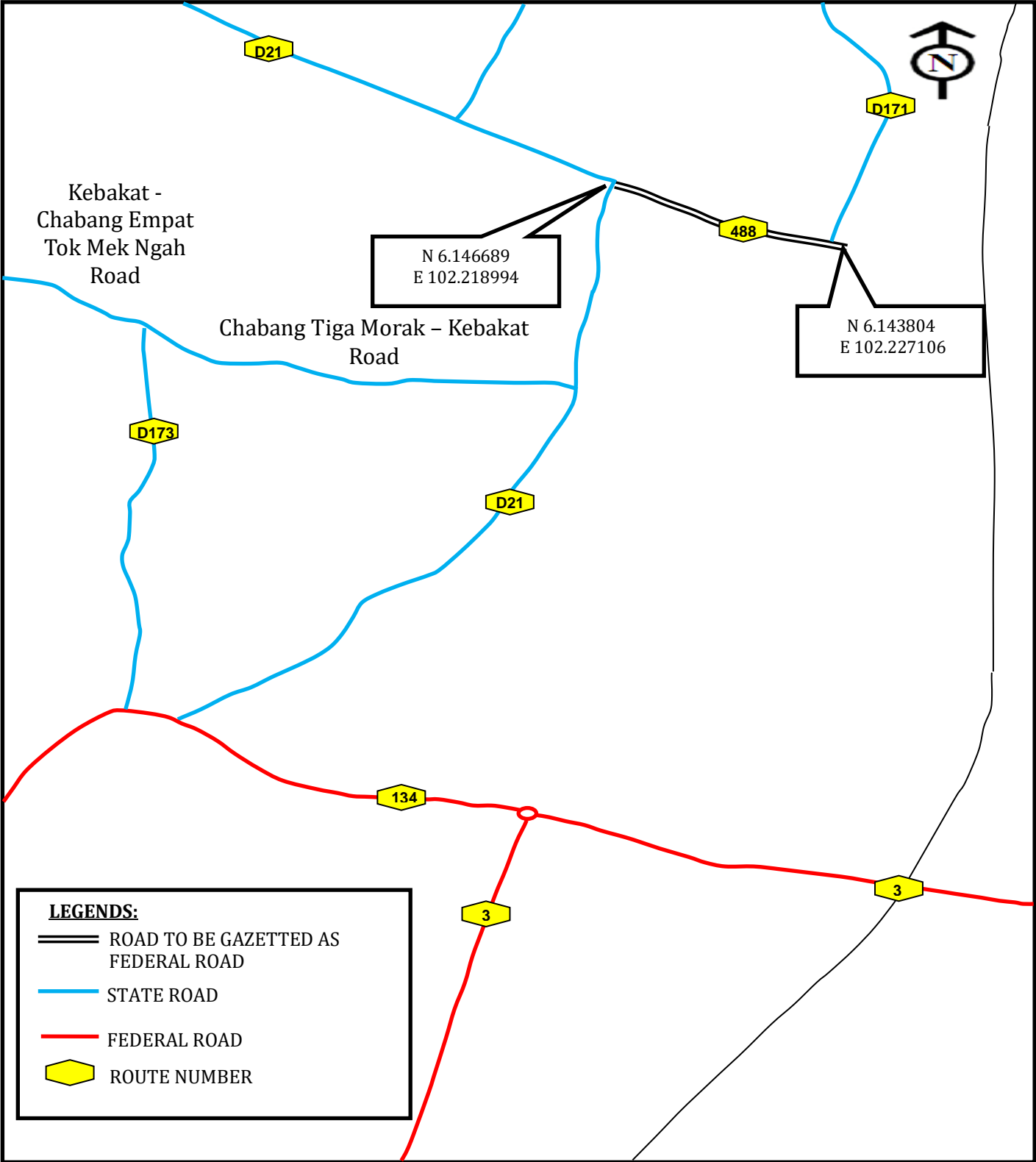
(a) by inserting after item 42 the following item:

“43. *(Route 488): Wakaf Bharu-Palekbang Road*

From its junction with Route D21, at coordinates N 6.146689, E 102.218994 and ending at coordinates N 6.143804, E 102.227106 within the boundaries of right of way as shown on MAP 17: WAKAF BHARU-PALEKBANG ROAD (a distance of 0.94 km).”; and

(b) by inserting after MAP 16: KADOK TO KETEREH ROAD the following map:
