ENTERTAINMENTS DUTY ACT 1953

ENTERTAINMENTS DUTY (EXEMPTION) (NO. 24) 2006 (REVOCATION) ORDER 2020

IN exercise of the powers conferred by subsection 12(1)(a) of the Entertainments Duty Act 1953 [*Act 103*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Entertainments Duty (Exemption) (No. 24) 2006 (Revocation) Order 2020**.

(2) This Order comes into operation on 1 August 2020.

2. The Entertainments Duty (Exemption) (No. 24) Order 2006 [*P.U. (A) 251/2006*] is revoked.
