**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Mesin Cetak dan Penerbitan (Kawalan Hasil Penerbitan Tidak Diingini) 2020**.

**Larangan**

2. Pencetakan, pengimportan, penghasilan, penghasilan semula, penerbitan, penjualan, pengeluaran, pengelilingan, pengedaran atau pemilikan hasil penerbitan yang diperihalkan dalam Jadual yang mungkin memudaratkan ketenteraman awam, yang mungkin memudaratkan keselamatan, yang mungkin menggemparkan fikiran orang ramai, yang mungkin berlawanan dengan mana-mana undang-undang dan yang mungkin memudaratkan kepentingan negara adalah dilarang secara mutlak di seluruh Malaysia.

## PRINTING PRESSES AND PUBLICATIONS ACT 1984

PRINTING PRESSES AND PUBLICATIONS  
(CONTROL OF UNDESIRABLE PUBLICATIONS) ORDER 2020

IN exercise of the powers conferred by subsection 7(1) of the Printing Presses and Publications Act 1984 [*Act 301*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Printing Presses and Publications (Control of Undesirable Publications) Order 2020**.

**Prohibition**

2. The printing, importation, production, reproduction, publishing, sale, issue, circulation, distribution or possession of the publication described in the Schedule which is likely to be prejudicial to public order, which is likely to be prejudicial to security, which is likely to alarm public opinion, which is likely to be contrary to any law and which is likely to be prejudicial to national interest is absolutely prohibited throughout Malaysia.
