PERINTAH KOPERASI (PENGAMBILALIHAN KAWALAN KOPERASI PENEROKA

PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan Koperasi Peneroka Felda Kemahang (1) Berhad) (Pelantikan Semula) 2020**.

**Pelantikan semula bagi pengambilalihan kawalan**

2. Suruhanjaya melantik semula Mohd Shihabuddin bin Mohd Yazid untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Peneroka Felda Kemahang (1) Berhad, dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya bagi tempoh mulai 8 Julai 2020 hingga 7 Julai 2021 atau sehingga suatu Lembaga baharu dipilih di bawah undang-undang kecil Koperasi itu, mengikut mana-mana yang terdahulu.

**Kos, perbelanjaan dan saraan**

3. Apa-apa kos dan perbelanjaan yang dilakukan oleh Suruhanjaya, dan saraan bagi orang yang dilantik semula di bawah perenggan 2, berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Peneroka Felda Kemahang (1) Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL OF KOPERASI PENEROKA  
FELDA KEMAHANG (1) BERHAD) (REAPPOINTMENT) ORDER 2020

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [Act 502], the Commission makes the following order:

**Citation**

1. This order may be cited as the **Co-operative Societies (Assumption of Control of Koperasi Peneroka Felda Kemahang (1) Berhad) (Reappointment) Order 2020**.

**Reappointment for assumption of control**

2. The Commission reappoints Mohd Shihabuddin bin Mohd Yazid to assume control of the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad, and carry on the whole of its business, activities and affairs for the period from 8 July 2020 until 7 July 2021 or until a new Board is elected under the by-laws of the Co-operative society, whichever is earlier.

**Costs, expenses and remuneration**

3. Any costs and expenses incurred by the Commission, and the remuneration of the person reappointed under paragraph 2, in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Peneroka Felda Kemahang (1) Berhad as a first charge.
