PERINTAH PERNIAGAAN PERKHIDMATAN WANG (PENGECUALIAN FI) 2020

MONEY SERVICES BUSINESS ACT 2011

MONEY SERVICES BUSINESS (EXEMPTION OF FEES) ORDER 2020

IN exercise of the powers conferred by section 91 of the Money Services Business Act 2011 [Act 731], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Money Services Business (Exemption of Fees) Order 2020**.

(2) This Order comes into operation on 1 June 2020.

Exemption of fees

2. The Minister exempts a licensee from the requirements of section 8 of the Act in respect of payment of an annual fee as specified in item 3 of paragraph 1 of the Second Schedule to the Money Services Business (Licensing) Regulations 2012 [P.U. (A) 70/2012] for the year 2020.
