CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 3) ORDER 2020

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 3) Order 2020**.

**Controlled articles**

2. The articles specified in the Schedule are declared to be controlled articles for the period from 28 May 2020 to 3 June 2020.
