Citation

1. This order may be cited as the **Prevention and Control of Infectious Diseases (Declaration of Infected Local Areas) (Extension of Operation) (No. 3) Order 2020**.

Extension of operation

2. The operation of the Prevention and Control of Infectious Diseases (Declaration of Infected Local Areas) Order 2020 [P.U. (A) 87/2020] which had been extended for the period from 15 April 2020 to 28 April 2020 by the Prevention and Control of Infectious Diseases (Declaration of Infected Local Areas) (Extension of Operation) (No. 2) Order 2020 [P.U. (A) 116/2020] is further extended for a period from 29 April 2020 to 12 May 2020.
