AKTA KOPERASI 1993

PERINTAH KOPERASI (PENGAMBILALIHAN KAWALAN KOPERASI SAKILAN
SANDAKAN BERHAD) (PELANTIKAN SEMULA) 2020

PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan Koperasi Sakilan Sandakan Berhad) (Pelantikan Semula) 2020**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 17 November 2017.

Pelantikan semula bagi pengambilalihan kawalan

2. Suruhanjaya telah melantik semula Kastian bin Hj. Dula untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Sakilan Sandakan Berhad, dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya bagi tempoh mulai 17 November 2017 hingga 27 Oktober 2018.

Kos dan perbelanjaan

3. Apa-apa kos dan perbelanjaan yang dilakukan oleh Suruhanjaya, dan saraan bagi orang yang dilantik semula di bawah perenggan 2, berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Sakilan Sandakan Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES ACT 1993**CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL OF KOPERASI SAKILAN SANDAKAN BERHAD) (REAPPOINTMENT) ORDER 2020**

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [*Act 502*], the Commission makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Co-operative Societies (Assumption of Control of Koperasi Sakilan Sandakan Berhad) (Reappointment) Order 2020**.

(2) This Order is deemed to have come into operation on 17 November 2017.

Reappointment of assumption of control

2. The Commission has reappointed Kastian bin Hj. Dula to assume control of the whole of the property, business, activities and affairs of the Koperasi Sakilan Sandakan Berhad, and carry on the whole of its business, activities and affairs for the period from 17 November 2017 until 27 October 2018.

Costs and expenses

3. Any costs and expenses incurred by the Commission, and the remuneration of the person reappointed under paragraph 2, in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Sakilan Sandakan Berhad as a first charge.
