AKTA SISTEM INSURANS PEKERJAAN 2017

PERATURAN-PERATURAN SISTEM INSURANS PEKERJAAN (PERATURAN-PERATURAN
SISTEM INSURANS PEKERJAAN (PENDAFTARAN DAN CARUMAN) 2017)
(PENGUBAHSUAIAN SEMENTARA) 2020

PADA menjalankan kuasa yang diberikan oleh subseksyen 85(2) Akta Sistem Insurans Pekerjaan 2017 [*Akta 800*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Sistem Insurans Pekerjaan (Peraturan-Peraturan Sistem Insurans Pekerjaan (Pendaftaran dan Caruman) 2017) (Pengubahsuaian Sementara) 2020**.

(2) Peraturan-Peraturan ini hendaklah berkuat kuasa bagi bayaran caruman bagi bulan April 2020 sehingga bulan September 2020.

2. (1) Subperaturan 9(1) Peraturan-Peraturan Sistem Insurans Pekerjaan (Pendaftaran dan Caruman) 2017 [*P.U. (A) 452/2017*] diubah suai dengan menggantikan perkataan “hari yang kelima belas” dengan perkataan “hari terakhir”.

EMPLOYMENT INSURANCE SYSTEM ACT 2017

EMPLOYMENT INSURANCE SYSTEM (EMPLOYMENT INSURANCE SYSTEM
(REGISTRATION AND CONTRIBUTION) REGULATIONS 2017) (TEMPORARY
MODIFICATION) REGULATIONS 2020

IN exercise of the powers conferred by subsection 85(2) of the Employment Insurance System Act 2017 [*Act 800*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Employment Insurance System (Employment Insurance System (Registration and Contribution) Regulations 2017) (Temporary Modification) Regulations 2020**.

(2) These Regulations shall have effect for the payment of contribution for the month of April 2020 until the month of September 2020.

Temporary modification for payment of contribution

2. (1) Subregulation 9(1) of the Employment Insurance System (Registration and Contribution) Regulations 2017 [*P.U. (A) 452/2017*] is modified by substituting for the words “the fifteenth day” the words “the last day”.
