PERATURAN-PERATURAN PERKHIDMATAN POS  
(KAEDAH-KAEDAH PEJABAT POS, 1947) (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh perenggan 100(o) Akta Perkhidmatan Pos 2012 [*Akta 741*], Menteri, atas syor Suruhanjaya, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkhidmatan Pos (Kaedah-Kaedah Pejabat Pos, 1947) (Pindaan) 2020**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Februari 2020.

**Pindaan kaedah 3**

2. Kaedah-Kaedah Pejabat Pos, 1947 [*M.U. G.N. 8436 Tahun 1947*], yang disebut “Kaedah-Kaedah ibu” dalam Peraturan-Peraturan ini, dipinda dalam kaedah 3 dengan memotong takrif “parcel” dan “postcard”.

**Pemotongan Bahagian, kaedah dan subkaedah**

3. Kaedah-Kaedah ibu dipinda—

(a) dengan memotong Bahagian X, XI, XIV, XXIII dan XXIV;

(b) dengan memotong kaedah 8A, 16, 19, 30, 58, 136, 137, 138, 139, 140, 141, 142, 143, 144 dan 148; dan

(c) dengan memotong subkaedah 25(4).

POSTAL SERVICES ACT 2012

POSTAL SERVICES (POST OFFICE RULES, 1947) (AMENDMENT)  
REGULATIONS 2020

IN exercise of the powers conferred by paragraph 100(*o*) of the Postal Services Act 2012 [*Act 741*], the Minister, on the recommendation of the Commission, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Postal Services (Post Office Rules, 1947) (Amendment) Regulations 2020**.

(2) These Regulations come into operation on 1 February 2020.

**Amendment of rule 3**

2. The Post Office Rules, 1947 [*M.U. G.N. 8436 of 1947*], which are referred to as the “principal Rules” in these Regulations, are amended in rule 3 by deleting the definitions of “parcel” and “postcard”.

**Deletion of Part, rules and subrule**

3. The principal Rules are amended—

(*a*) by deleting Parts X, XI, XIV, XXIII and XXIV;

(*b*) by deleting rules 8A, 16, 19, 30, 58, 136, 137, 138, 139, 140, 141, 142, 143, 144 and 148; and

(*c*) by deleting subrule 25(4).
