PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (LEBUH RAYA SEREMBAN-PORT DICKSON) (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Seremban-Port Dickson) (Pindaan) 2020**.

(2) Perintah ini mula berkuat kuasa pada 1 Februari 2020.

Pindaan perenggan 2

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Seremban-Port Dickson) 2004 [*P.U. (A) 326/2004*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 2(1) dengan menggantikan perkataan “12 Januari 2012 sehingga 31 Mei 2038” dengan perkataan “1 Februari 2020 sehingga 31 Disember 2058”.

Penggantian Jadual Pertama

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(SEREMBAN-PORT DICKSON EXPRESSWAY) (AMENDMENT) ORDER 2020

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Seremban-Port Dickson Expressway) (Amendment) Order 2020**.

(2) This Order comes into operation on 1 February 2020.

Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Seremban-Port Dickson Expressway) Order 2004 [*P.U (A) 326/2004*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 2(1) by substituting for the words “12 January 2012 to 31 May 2038” the word “1 February 2020 to 31 December 2058”.

Substitution of First Schedule

3. The principal Order is amended by substituting for the First Schedule the following Schedule:

RATES OF TOLL FOR THE PERIOD FROM 1 FEBRUARY 2020 UNTIL 31 DECEMBER 2058

	<i>Mambau Toll Plaza</i>	<i>Lukut East and West Toll Plazas</i>
1. Vehicles with two axles and three or four wheels (excluding taxis and buses)	2.62	0.65
2. Vehicles with two axles and five or six wheels (excluding buses)	6.30	1.40
3. Vehicles with three axles or more (excluding buses)	9.50	2.20
4. Taxis	2.62	0.65
5. Buses	5.16	1.14

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”.
