AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) 2020**.

(2) Perintah ini mula berkuat kuasa pada 31 Januari 2020.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Sarawak) 1996 [*P.U. (A) 551/1996*] yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala “LEBUH RAYA PAN BORNEO” dengan memasukkan selepas butiran (*ja*) dengan butiran yang berikut:

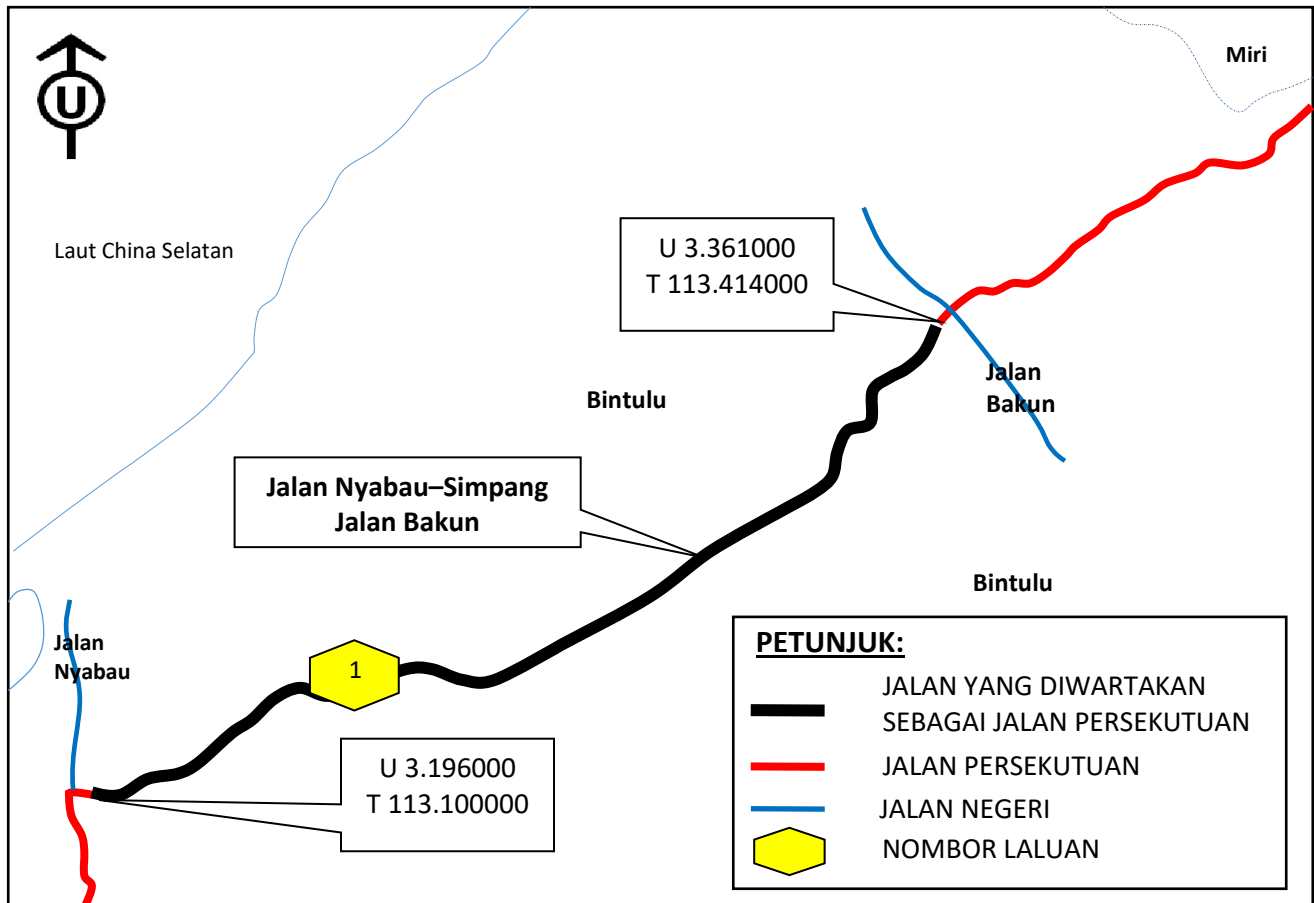
“(jb) (*Laluan 1*): *Jalan Nyabau-Simpang Jalan Bakun*

Bermula dari Jalan Nyabau di koordinat U 3.196000, T 113.100000 dan berakhir di simpang Jalan Bakun di koordinat U 3.361000, T 113.414000 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA JALAN NYABAU-SIMPANG JALAN BAKUN (jarak sepanjang 42.273 km).”.

Pindaan Jadual Ketiga

3. Perintah ibu dipinda dalam Jadual Ketiga dengan memasukkan selepas PETA JALAN TELOK MELANO-BULATAN SEMATAN peta yang berikut:

“PETA JALAN NYABAU-SIMPANG JALAN BAKUN

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) ORDER 2020

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Sarawak) (Amendment) Order 2020**.

(2) This Order comes into operation on 31 January 2020.

Amendment of First Schedule

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1996*] which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading “PAN BORNEO HIGHWAY” by inserting after item *(ja)* the following item:

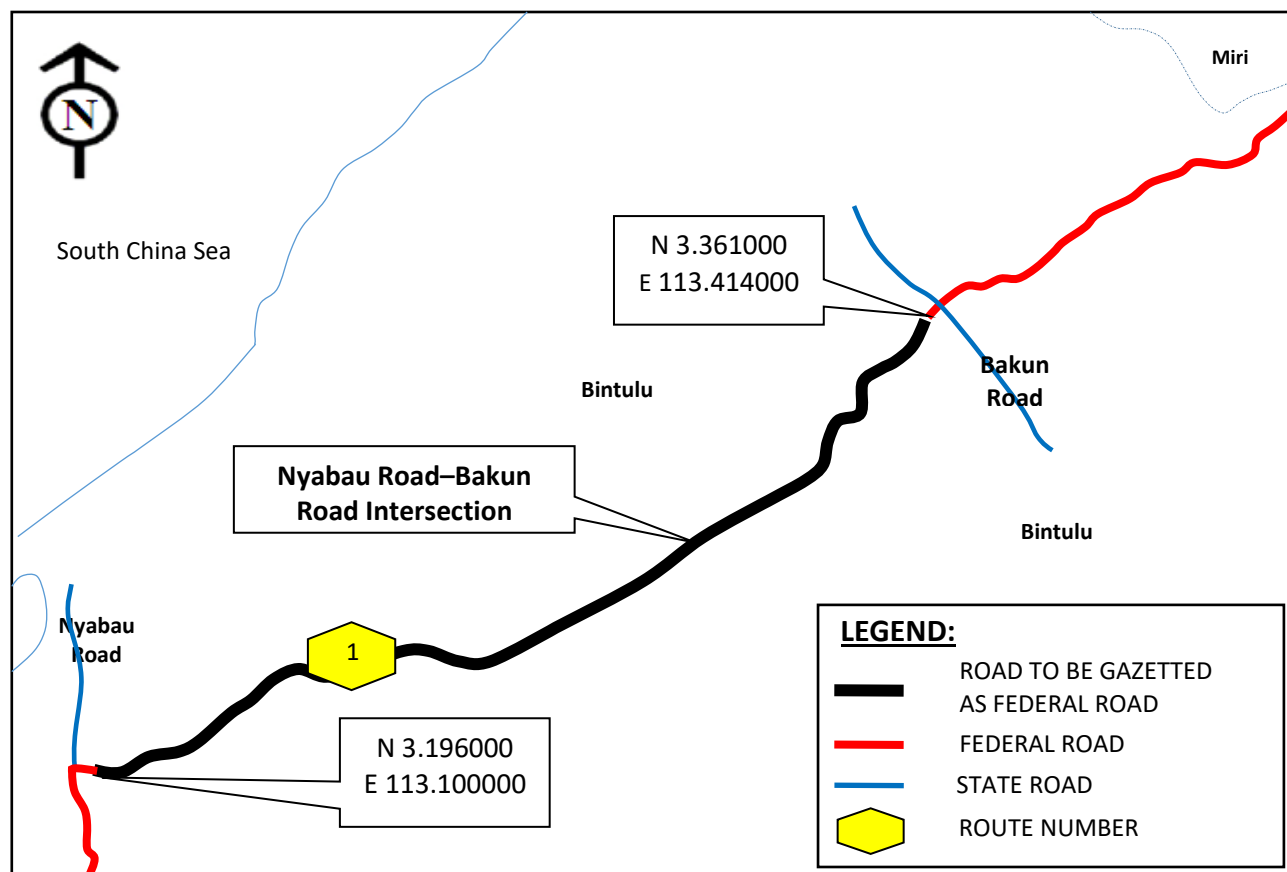
“(jb) (Route 1): Nyabau Road–Bakun Road Intersection

Starting from Nyabau Road at coordinates N 3.196000, E 113.100000 and ending at Bakun Road intersection at coordinates N 3.361000, E 113.414000 within the boundaries of right of way as shown on MAP OF NYABAU ROAD-BAKUN ROAD INTERSECTION (a distance of 42.273 km).”.

Amendment of Third Schedule

3. The principal Order is amended in the Third Schedule by inserting after MAP OF TELOK MELANO-SEMATAN ROUNDABOUT ROAD the following map:
