AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 6) 2019

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 6) 2019**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2020.

Perenggan 1A baharu

2. Perintah Kastam (Larangan Mengenai Import) 2017 [*P.U. (A) 103/2017*], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dengan memasukkan selepas perenggan 1 perenggan yang berikut:

" Tafsiran

1A. Dalam Perintah ini, "barang-barang dalam transit" ertinya pergerakan barang-barang dari suatu pejabat kastam di mana-mana negara ke suatu pejabat kastam di Malaysia (termasuk barang-barang untuk pindah kapal) bagi tujuan untuk ke negara lain sahaja."

Pindaan perenggan 3, 4, 7 dan 10

3. Subperenggan 3(2), 4(3), 7(3) dan 10(3) Perintah ibu dipinda dengan menggantikan perkataan "Labuan, Langkawi dan Tioman" dengan perkataan "Labuan, Langkawi, Tioman dan Pangkor".

Pindaan perenggan 5

4. Perenggan 5 Perintah ibu dipinda—

(a) dalam nota bahu dengan memasukkan selepas perkataan “Tioman” perkataan “, Pangkor”;

(b) dalam subperenggan (2)—

(i) dengan memotong perkataan “dan” di hujung subsubperenggan (c); dan

(ii) dengan memasukkan selepas subsubperenggan (c) subsubperenggan yang berikut:

“ (ca) Pangkor; dan”; dan

(c) dalam subperenggan (3), dengan memasukkan selepas perkataan “Tioman” perkataan “, Pangkor”.

Pindaan Jadual Kedua

5. Bahagian III Jadual Kedua kepada Perintah ibu dipinda dalam tajuk dengan memasukkan selepas perkataan “Tioman” perkataan “, Pangkor”.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 6) ORDER 2019

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 6) Order 2019**.

(2) This Order comes into operation on 1 January 2020.

New paragraph 1A

2. The Customs (Prohibition of Imports) Order 2017 [*P.U. (A) 103/2017*], which is referred to as the “principal Order” in this Order, is amended by inserting after paragraph 1 the following paragraph:

“ Interpretation

1A. In this Order, “goods in transit” means the movement of goods from a customs office in any country to a customs office in Malaysia (including goods on transshipment) for the sole purpose of being carried out to another country.”.

Amendment of paragraphs 3, 4, 7 and 10

3. Subparagraphs 3(2), 4(3), 7(3) and 10(3) of the principal Order is amended by substituting for the words “Labuan, Langkawi and Tioman” the words “Labuan, Langkawi, Tioman and Pangkor”.

Amendment of paragraph 5

4. Paragraph 5 of the principal Order is amended—

(a) in the shoulder note, by inserting after the word “Tioman” the words “, Pangkor”;

(b) in subparagraph (2)—

(i) by deleting the words “and” at the end of the subsubparagraph (c); and

(ii) by inserting after subsubparagraph (c) the following subsubparagraph:

“ (ca) Pangkor; and”; and

(c) in subparagraph (3), by inserting after the word “Tioman” the words
“, Pangkor”.

Amendment of the Second Schedule

5. Part III of the Second Schedule to the principal Order is amended in the title by inserting after the word “Tioman” the words “, Pangkor”.
