CENTRAL LINK AND KUALA LUMPUR-JOHORE BAHRU EXPRESSWAY)  
(AMENDMENT) (NO. 2) ORDER 2019

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Juru-Jalan Duta-Bukit Raja Expressway, North South Expressway Central Link and Kuala Lumpur-Johore Bahru Expressway) (Amendment) (No. 2) Order 2019**.

(2) This Order comes into operation on 1 January 2020.

**General amendment**

2. The Federal Roads (Private Management) (Collection of Tolls) (Juru-Jalan Duta-Bukit Raja Expressway, North South Expressway Central Link and Kuala Lumpur-Johore Bahru Expressway) Order 2002 [*P.U. (A) 171/2002*] is amended by substituting for the words “31 DECEMBER 2019” and “31 December 2019” wherever appearing the words “31 DECEMBER 2020” and “31 December 2020” respectively.
