FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(BUTTERWORTH-KULIM EXPRESSWAY) (AMENDMENT) ORDER 2019

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Butterworth-Kulim Expressway) (Amendment) Order 2019**.

(2) This Order comes into operation on 1 January 2020.

Amendment of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Butterworth-Kulim Expressway) Order 1996 [*P.U. (A) 564/1996*] is amended in the heading of the First Schedule by substituting for the words “31 DECEMBER 2019” the words “31 DECEMBER 2020”.
