CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (KOPERASI SAHABAT AMANAH IKHTIAR MALAYSIA
BERHAD) (EXEMPTION) ORDER 2019

IN exercise of the powers conferred by section 87 of the Co-operative Societies Act 1993 [Act 502], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Co-operative Societies (Koperasi Sahabat Amanah Ikhtiar Malaysia Berhad) (Exemption) Order 2019**.

(2) This Order is deemed to have come into operation on 30 September 2018.

Exemption

2. Koperasi Sahabat Amanah Ikhtiar Malaysia Berhad is exempted from the application of subsection 43(4) of the Act for the purpose of the appointment of the members of the Board of Koperasi Sahabat Amanah Ikhtiar Malaysia Berhad at the annual general meeting of delegates for the 2018/2019 session.
