AKTA RACUN MAKHLUK PEROSAK 1974

PERINTAH RACUN MAKHLUK PEROSAK (PENGECUALIAN) (NO. 5) 2019

PADA menjalankan kuasa yang diberikan oleh seksyen 59 Akta Racun Makhluk Perosak 1974 [*Akta 149*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Racun Makhluk Perosak (Pengecualian) (No. 5) 2019**.

(2) Perintah ini mula berkuat kuasa pada 15 Disember 2019.

Pengecualian

2. Tertakluk kepada perenggan 3, Menteri mengecualikan Agricultural Chemicals (M) Sdn. Bhd. (No. Syarikat 008938-M) daripada larangan di bawah perenggan 13(1)(b) Akta bagi maksud mengilang racun makhluk perosak dan kehendak di bawah perenggan 15(2)(a) Akta bagi maksud permohonan bagi lesen untuk mengilang racun makhluk perosak.

Syarat pengecualian

3. Pengecualian di bawah perenggan 2 adalah tertakluk kepada syarat bahawa racun makhluk perosak itu hendaklah dikilangkan di bawah suatu perjanjian untuk orang yang mendaftar racun makhluk perosak itu.

PESTICIDES ACT 1974

PESTICIDES (EXEMPTION) (NO. 5) ORDER 2019

IN exercise of the powers conferred by section 59 of the Pesticides Act 1974 [*Act 149*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Pesticides (Exemption) (No. 5) Order 2019**.

(2) This Order comes into operation on 15 December 2019.

Exemption

2. Subject to paragraph 3, the Minister exempts Agricultural Chemicals (M) Sdn. Bhd. (Company No. 008938-M) from the prohibition under paragraph 13(1)(b) of the Act for the purpose of manufacturing a pesticide and the requirement under paragraph 15(2)(a) of the Act for the purpose of application for a licence to manufacture a pesticide.

Condition of exemption

3. The exemption under paragraph 2 is subject to the condition that the pesticide shall be manufactured under an agreement for the registrant of the pesticide.
