PERINTAH KOPERASI (PENGAMBILALIHAN KAWALAN KOPERASI GURU-GURU DTC

PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [Akta 502], Suruhanjaya membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan Koperasi Guru-Guru DTC Malaysia Berhad) (Pelantikan Semula) 2019**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 30 Mac 2019.

Pelantikan semula bagi pengambilalihan kawalan

2. Suruhanjaya telah melantik semula Mohd Shihabuddin bin Mohd Yazid untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Guru-Guru DTC Malaysia Berhad dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya bagi tempoh mulai 30 Mac 2019 hingga 30 April 2019.

Kos dan perbelanjaan

3. Apa-apa kos dan perbelanjaan yang dilakukan oleh Suruhanjaya berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Guru-Guru DTC Malaysia Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL OF KOPERASI GURU-GURU
DTC MALAYSIA BERHAD) (REAPPOINTMENT) ORDER 2019

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [Act 502], the Commission makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Co-operative Societies (Assumption of Control of Koperasi Guru-Guru DTC Malaysia Berhad) (Reappointment) Order 2019**.

(2) This Order is deemed to have come into operation on 30 March 2019.

Reappointment of assumption of control

2. The Commission has reappointed Mohd Shihabuddin bin Mohd Yazid to assume control of the whole of the property, business, activities and affairs of the Koperasi Guru-Guru DTC Malaysia Berhad and carry on the whole of its business, activities and affairs for the period from 30 March 2019 until 30 April 2019.

Costs and expenses

3. Any costs and expenses incurred by the Commission in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Guru-Guru DTC Malaysia Berhad as a first charge.
