PRINTING PRESSES AND PUBLICATIONS
(CONTROL OF UNDESIRABLE PUBLICATIONS) (REVOCATION) ORDER (NO. 2) 2019

IN exercise of the powers conferred by subsection 7(1) of the Printing Presses and Publications Act 1984 [Act 301], the Minister revokes the prohibition of printing, importation, production, reproduction, publishing, sale, issue, circulation, distribution or possession of publication of *Assalamualaikum (May Peace Be Upon You) : Observations On The Islamisation Of Malaysia* which has been published vide the Printing Presses and Publications (Control of Undesirable Publications) (No. 39) Order 2017 [P.U. (A) 395/2017].
