WATER SERVICES INDUSTRY ACT 2006

WATER SERVICES INDUSTRY (LICENSING) (EXEMPTION) (NO. 3) ORDER 2019

IN exercise of the powers conferred by section 5 of the Water Services Industry Act 2006 [Act 655], the Minister, upon the recommendation of the Commission, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Water Services Industry (Licensing) (Exemption) (No. 3) Order 2019**.

(2) This Order has effect for the period from 15 September 2019 to 14 September 2020.

Exemption

2. Water Engineering Technology Sdn. Bhd. is exempted from requirement for individual licence under section 4 of the Act for raw water pumping work from Semantan River pump house, Pahang to Langat 2 Water Treatment Plant, Selangor.
