PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Utara Selatan Hubungan Tengah dan Lebuh Raya KLIA) (Pindaan) 2019**.

(2) Perintah ini mula berkuat kuasa pada 6 September 2019.

Pindaan perenggan 3

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Utara Selatan Hubungan Tengah dan Lebuh Raya KLIA) 2002 [*P.U. (A) 437/2002*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 3(1) dengan menggantikan perkataan “Jadual Ketiga G” di mana-mana jua terdapat dengan perkataan “Jadual Ketiga H”.

Kelas 4: Teksi

Kelas 5: Bas

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(NORTH SOUTH EXPRESSWAY CENTRAL LINK AND KLIA EXPRESSWAY)
(AMENDMENT) ORDER 2019

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (North South Expressway Central Link and KLIA Expressway) (Amendment) Order 2019**.

(2) This Order comes into operation on 6 September 2019.

Amendment of paragraph 3

2. The Federal Roads (Private Management) (Collection of Tolls) (North South Expressway Central Link and KLIA Expressway) Order 2002 [*P.U. (A) 437/2002*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 3(1) by substituting for the words “Third Schedule G” wherever appearing the words “Third Schedule H”.

New Third Schedule H

3. The principal Order is amended by inserting after Third Schedule G the following Schedule:

CLASSES OF VEHICLES

- Class 1: Vehicles having two axles and three or four wheels (excluding taxis and buses)
- Class 2: Vehicles having two axles and five or six wheels (excluding buses)
- Class 3: Vehicles having three axles or more (excluding buses)

Class 4: Taxis

Class 5: Buses

For the purposes of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”
